On the smaller person three fingers appear to have been severed from the left hand. This must been done in grasping the death dealing knife of his larger foe.


No other marks were found on the skeleton to bear witness to this old tragedy-so silent, so swift and so fatal. Time has obliterated all other evidences of that horrible struggle.
