Lassen county will on the 1st of March vote on the question as to issuing bonds for the purpose of erecting a courthouse and high school building. It is claimed that the bond issue will not increase the tax rate materially. This is about the last county, excepting Modoc, that is in need of such buildings, and ere long Modoc county will get into the band wagon and ride.—New Era.

In an experimental flight at Los Angeles, Cal., Baldwin's airship performed with entire satisfaction, demonstrating that it can be controlled as easily as an automobile. The ship rose to a height of nearly 1500 feet, readily responded to every demand of the operator, mening at his will no short angles, described people circles, and was landed at the place from which it started.

A large tract of land has been secured in Texas, on which 1000 Japanese colonists are to locate, for the purpose of engaging in growing and manufacturing silk. Japanese having expert knowledge of soils, climates, and all that is essential to success in silk culture, have decided that the locality is in every way suitable and adapted to the industry.

The city of Warsaw, the ancient capital of Poland, is ruled by savage mobs, and still more savage soldiers. Russian bayonets are fixed to the streets of her cities are red with the blood of her citizens. Men, women and children are ruthlessly attacked, and the harvest of death is appalling. Must have Good Roads.

A committee composed of County Judge J. E. Scott, F. A. Wiggins and H. D. Patton will this morning begin a canvass among the business men of Salem in an effort to raise a \$2,000 purse to be put up for "good roads prizes." The plan, as has previously been stated in the columns of the Statesman, is to raise \$2,000 by subscription to which amount the county will add the sum of \$800, which will make a total fund of \$2800. This fund is to be divided into seven prizes from \$700 down to \$100, to be awarded to the seven road districts contiguous to Salem which will accomplish the most and best amount of permanent road building during the coming season. If the amount is raised the county court, in addition to the donation of \$800, offers to furnish expenses of its operation, which will insure the best and most adapted material for use in the road construction.

The amount raised by the special levy of 1 1/2 mills for road purposes is woefully inadequate to meet the demands made by different districts and the excellent plan outlined above has been decided upon to bring about the construction of good highways leading to Salem. Before either of the prizes would be awarded to any district it would be required that the district donate work to an amount of which the prize awarded would equal 40 per cent. This would amount an expenditure of at least \$10,000 during the present year, upon the roads leading to Salem, and would bring excellent results.—Oregon Statesman
