**Klamath Falls Waking Up.**

The delay on the part of the large land owners of Klamath county in signing up their lands to the Reclamation Service is causing a great deal of uneasiness among those who see in the Reclamation project for the Klamath Basin the life of the county. A meeting was called at Klamath Falls last week by citizens of that town to talk over some facts that presented a most dangerous appearance. Those facts were the ones published in The Examiner weeks before last regarding the manner in which the Reclamation Service was receiving the actions of these large land owners. In giving these facts to our readers two weeks ago, we expressed our desire to see Lake county get in now and make an effort to secure some of the money at the disposal of the service for reclamation work in Oregon. We pointed out that other projects in the state were practically established still just now as a result of the resistance of the large land owners in signing up their land, and as we believed there were no such obstacles in the way of reclamation in Lake county, the government might be induced to turn their attention this way and spend some of its money here. We believed we could see an opportunity, and now that Klamath Falls business men have become excited over the same facts, our belief is strengthened. Has Lake county a man who is energetic and public spirited enough to jump into the harness and get some work done here?

**Road Viewers Return.**

Harry Bailey and Lee Beall returned from Warner last Friday, where Mr. Bailey went to help view the road from Plush to Bonds, Lee Beall went along as "vaquero," and it is said inaugurated some new ideas among the Warner Valley vaqueros.

The road as viewed by the viewers, will be 18 miles long. It will cross the sloughs in the vicinity of Flag staff, where a bridge 127 feet long will have to be built. The banks of the slough are said to be firm, making it possible to construct a substantial bridge at that crossing. The water at that place is 6 feet deep now.

The viewers made a favorable report to the county court, and it is

expected the matter will be passed upon at this term and the road ordered opened.




