The Development League.

The fire that has been kindling for months under the smouldering Development League burst forth in illuminating flames of energy last Saturday evening when the time for the regular meeting of the League arrived, and one of the best, though not the largest in attendance, of these meetings was held that has been held since the League was organized. The absence of a president to call the meeting to order for several months has served as a handicap. The members who have never despaired, gathered at the Court House and elected Daniel Boone, one of the most enthusiastic members from the beginning, as chairman for the night.

Nothing of a disgruntled spirit has ever existed in the League, or caused it to smolder, but inactivity can easily be accounted for in the fact that all the officials, president and vice-president, have been, all summer long, so engrossed in business affairs, that no time was given to League business. Now that winter is on, the evenings are long and the rush of the season's business matters is over, there is no good reason to doubt that something will result from our organization.

Some of the features that enthused the meeting were the speeches, especially those of Dr. Daly, J. N. Watson and chairman Daniel Boone. Dr. Daly outlined a policy for the League to pursue and offered it as a suggestion, which met with the unanimous approval of the other members present. He dwelt long and fluently upon the possibilities of Lake county and the urgent need of a railroad, and pointed out reasonable solutions of the difficulties of securing what seems now paramount to our needs—railroads. A little smattering of jealousy of our sister county was visible on the speaker's stern countenance as he waxed eloquent over the possibilities of our own great county.

Pardonable as his jealousy may be, it is only acknowledgement of the inactivity on the part of influential men of this county that has permitted our neighbors to assume a more important standing than we claim. Let the spirit of emulation get into the hearts of every man in the county. It will stir him as nothing else will do. Let him taste the bitterness of rivalry, if the sweetness of a prosperous future will not drive him to activity. Let the world surge ahead and leave "the devil to take the hindmost," if he chooses to remain in his peaceful slumbers while awakening has seized his neighbor. We have not a single man in mind when we say these things, but the public in general.

Proud though we are, and ever have been, with fortune smiling upon our county, the time has come when fortune will cease to smile upon drollery; get a move on and if we have lagged, catch up with the rest of the feeling world. We are not behind, if we only will seize the opportunity that has offered much to others, and which is knocking at our door.

The meeting was called to order by the chairman pro tem., who called for the reading of the minutes of the previous meeting, which was approved as read. A few bills were allowed and a number of communications were read. The remainder of the evening was devoted to planning for a future course for the League.

Dr. Daly's suggestion to compile a complete report on the resources of the county as they exist, and the possibilities, was adopted.

Pays to Raise Good Hogs.
John A. Foster, the Summer Laker who has been trying for 20 years to get the people of Lake county interested in fine stock, while in Lakeview first of the week, stated to an Examiner representative that he had sold his registered cattle and thinking of going to Pine to get a start of fine hogs from C. M. Oliver, who has a bunch of registered Poland Chinas from the best strain in Illinois. He says it pays to raise the best, even for one's own use, when good hogs are made into bacon it goes on the market first at top prices, and it costs less to raise a good hog than it does to raise a scrub because the same feed will make a bigger hog.
Last week when Mr. Oliver was here he left some literature at this office praising very highly the strain of hogs he is dealing in. He has the pedigrees of all this bunch of hogs, which shows that they are just what he represents them to be.
