Charges Were False.

The Examiner congratulates the Mayor and council of the town of Lakeview, upon their prompt and thorough investigation of the serious charges printed in the Herald in a recent issue, against the public schools of Lakeview, and their report upon the same, which shows that all and every charge made was found to be without any foundation in fact and absolutely false in every particular.

We thoroughly agree with the committee's report, that "while publicity of public affairs is an excellent thing and should be encouraged, yet all publicity of public institutions should be based upon facts," and not published with slanderous intent to injure and defame the public institutions of Lake county.

The injury done to the public schools of Lakeview by the charges made, printed and sent broadcast by the Herald, though absolutely false in every particular, in the words of the committee, "has done irreparable injury, not only against the public schools, but against every public institution in Lake county."

The Herald's juvenile editor may believe that the "freedom of the press" may justify a license to defame, malign and vilify everyone, everything; even the public schools, against whom he may have a real or imaginary grievance. We believe, however, that there is a statute against such slanderous attacks upon the morals, peace and tranquility of the public, and would therefore, as a journalist claiming no rights through the "freedom of the press" to publish anything but the facts in a newspaper, recommend that the committee bring this whole matter to the attention of the district attorney for such action as he may deem best in the premises.

Another important meeting of the Lake County Development League was held at the court house last Saturday evening, and while not so very largely attended, was full of vim for the future welfare of Lake county. What was said by those present was to the point and had a meaning.

A committee was appointed whose duty it is to outline a policy, or in other words, formulate certain lines of work for the League and, if possible, learn through what channels the League can work to accomplish its purpose in carrying out the work laid down for it by this committee. This committee is composed of Daniel Boone, Dr. Daly and J. N. Watson.

The questions were asked, was there anything that a Development League could do to better the conditions of Lake county? was there anything that could better its conditions? and was there a way to bring about such conditions as was thought would be a benefit to the county? To each of these questions the answer was "yes."

The League has actually gone to work to accomplish something, and it is to be hoped may be crowned with success.

While nothing definite can be ascertained from any official source, it is believed that the Government will not bring Representative Hermann to trial, either in Portland or Washington, until after the adjournment of this session of Congress. Hermann's attorneys have intimated that they are in no hurry to have their client brought into court; in fact, Judge Guerin stated that Hermann would be "just as well pleased if his case was never brought to trial."

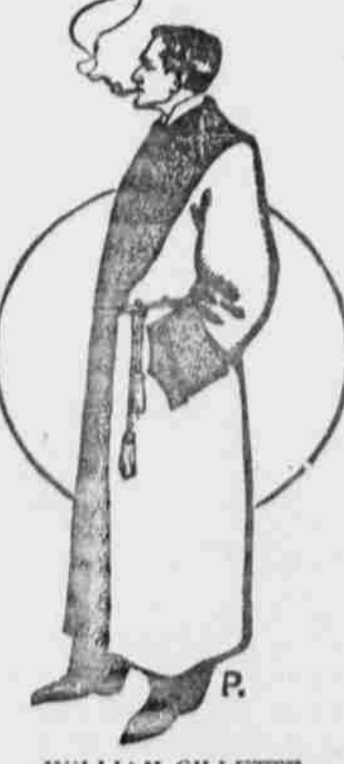
