Local Option and Liquor.

The Oregonian deals wisely and deeply with the liquor question; going more deeply into the matter we believe, than anyone yet dealing with it, even the anti-liquor people themselves. For they have only taken up one side of the question, and left many things unsaid that might throw light on the subject, and much to the dissatisfaction of the advocates of the traffic. The Oregonian starts with the revenue derived by the government from government revenue license paid by the manufacturers, which amounts to \$150,000,000 a year, and on down the line through states, counties, and incorporated cities and towns, where millions are expended for retail license. These revenues play an important part in feeding the government, and without them, the money would have to be derived from taxation. The Oregonian states that the operation of government would not be less expensive, and that the official system would not be cut down. We can hardly agree with The Oregonian that the expense of government would be as great as it is now, though the official system remain as it is, for the reason that, conceding that the consumption of liquor is responsible for a large portion of our criminal cases, the jury and witness fees in these criminal cases represent a considerable portion of the expense of the trials, and are paid out of the county's funds, and not borne by those funds set aside for the payment of salaries. It is plain to be seen by the Oregonian's article that it does not favor absolute prohibition, but is willing for local option to work out its salvation in the small communities.

It is our belief that, having the local option law, as we have it, if radicalism, on both sides will be cut out, and the law allowed to take its natural course, and liquor dealers will obey the law, wherever a town is found in forcing the laws and the saloons abiding by them, local option will not attempt to disturb the conditions there, but will hunt out the localities where the abuse of the license system has embittered the public against the traffic, and there will set to work, having the sentiment of a law abiding public to back it. We notice that in the Eastern states, where the wholesalers have become fearful of the spread of the prohibition wave that is making inroads on the trade, the wholesalers are refusing to sell to saloons that do not comply with the laws forced upon the statute books by prohibitionists as moderate measures. In this they expect to keep out radical legislation, and they are combined in their efforts.
