

IN THE COUNTY COURT OF THE STATE OF OREGON, FOR THE COUNTY OF LAKE

ORDER DECLARING RESULT OF ELECTION AND PROHIBITING THE SALE OF INTOXICATING LIQUORS IN SILVER LAKE PRECINCT NO. 1, SUMMER LAKE PRECINCT NO. 2, SOUTH WARNER PRECINCT NO. 3, AND COGSWELL CREEK PRECINCT NO. 11 OF LAKE COUNTY, OREGON.

It appearing to the satisfaction of the County Court that the question of prohibiting the sale of intoxicating liquors was at a general election held on the first day of June, 1908, voted upon by the voters of entire County of Lake, State of Oregon, as a whole:

That thereafter, to wit, on the fifth day of June, 1908, the same being the fourth day after the day of said election, the County Clerk E. N. Jaquish and Winslow Bayley and W. B. Snider, Justices of the Peace in and for Lake County, Oregon, did on said day at the County Clerk's office in the Town of Lakeview, Lake County, Oregon, then and there, open the returns of said election and made an abstract of the vote cast for and against the sale of intoxicating liquors as aforesaid within the whole of the said Lake County, Oregon:

That from the said abstract as returned by the said County Clerk and Justices of the Peace it appears, and it is hereby declared, that a majority of all the votes cast at said election in Silver Lake Precinct No. 1, in Summer Lake Precinct No. 2, in South Warner Precinct No. 3, and Cogswell Precinct No. 11 of Lake County, Oregon, were in favor of prohibiting the sale of intoxicating liquors in each of said Precincts:

Therefore, it is hereby considered and ordered that the sale of intoxicating liquors be and the same are absolutely prohibited within the territory embraced within the said Precincts of Silver Lake No. 1, Summer Lake No. 2, South Warner No. 3, and Cogswell Creek No. 11 in Lake County, Oregon, and which Precincts are more particularly described as follows, to wit:

Silver Lake Precinct No. 1. Commencing at North East Cor. of Lake County, thence West to North West Cor. of the County, thence South along the Western boundary of said County to the South West Cor. of Township 32, South Range 12 East, thence East to South East Cor. of Township 32, South Range 14 East, thence North to North West Cor. of Township 31, South Range 15 East, thence East to South East Cor. of Township 30, South Range 15 East, thence North to the North East Cor. of Section 24, Township 29, South Range 15 East, thence East to East-south boundary of Township 29, South Range 16 East, thence North to North East Cor. of same Township, thence East to the Eastern boundary of the County, thence North to the place of beginning.

Summer Lake Precinct No. 2. Commencing at South West Cor. of Township 32, South Range 15 East, thence North to North West Cor. of Township 31, South Range 15 East, thence East to South East Cor. of Township 30, South Range 15 East, thence North to North East Cor. of Section 24, Township 29, South Range 15 East, thence East to the Eastern boundary of Township 29, South Range 16 East, thence North to the North East Cor. of same Township and Range, thence East to the Eastern boundary of the County, thence South along the Eastern boundary of the County to the boundary line, between Township 30 and 31, South, thence West to South East Cor. of Township 30, South Range 22 East, thence South to South East Cor. of Township 31, South Range 22 East, thence West 12 miles, thence South to North East Cor. of Township 33, South Range 20 East, thence West to place of beginning.

South Warner Precinct No. 3. Beginning at the South East Cor. of Lake County, thence North to the North East Cor. of Section 12, Township 38, South Range 23 East, thence West 36 miles, thence South to the South West Cor. of Township 31, South Range 23, thence East along the State line to place of beginning.

Cogswell Creek Precinct No. 11. Beginning at the South East Cor. of Township 41, South Range 22 East, thence West to a point on the State line where the meander line of Goose Lake intersects the same, thence Northerly along the said line to the point where the Section line and continuation thereof between sections 9 and 10, Township 40, South Range 20 East intersects said meander line, thence North along said Section line to the South West Cor. of the Corporate limits of the Town of Lakeview, thence East along the South boundary of said Corporate limits to the South East boundary thereof, thence North to the South West Cor. of Section 11, Township 39, South Range 20 East, thence East to the North East Cor. of Section 13, Township 39, South Range 22 East, thence South to the place of beginning.

This order to take effect and be in full force on and after the first day of July, 1908.

LAYS IT TO THE HARD TIMES

Tells His Hearers That Women in America Have at Last Been Recognized as Reasoning, Thinking Human Beings.

It has taken thousands of years to do it, but she has at last been recognized as a reasoning, thinking human being. It is an era that we should all be proud of. We should all be glad to acclaim her as man's equal, and yet dangers lurk in the path. There is a fear that woman may go too far and wield her influence in the wrong direction.

To the wives present I wish to recall the name of Christopher Columbus. We all know what he did, but very few of us know that he would have accomplished the same thing at least fifteen years before but for his wife. He had got it into his head that there were other countries to discover, and he was thinking and planning. When he told his thoughts and plans to his wife she put her foot on them. She wanted him to stay home and milk the cow and split the wood and make garden, and she raised such a row about it that he remained and did not get away until after her death. Had she lived on thirty years more where would this country have been? Who would have heard the name of Columbus to remember it an hour? He would never have got farther than the city hall, and he would never have been heard of outside of his own ward.

Columbus came at last and discovered us, and now you find us a nation of 80,000,000 people, but suppose his wife had let him come fifteen years before? We'd have had at least 300 more trusts by this time, and the present financial stringency would have been a thing of the past. We'd have also known whether Mr. Roosevelt was going to run again or not.

And I call your attention to the case of Benjamin Franklin. Mrs. Franklin was a good soul, and no doubt she made the best pumpkin pies in Philadelphia, but she didn't understand ambitions in a man. Just when Benjamin was forging to the front she wanted him to turn in his tracks and open a shoe store. She not only wanted it, but she insisted on it, and the hired girl says they had a regular row. Suppose she had carried her point. Suppose the great and wise Franklin had foregone his ambitions and become a boot and shoe man and squeezed No. 4 shoes on to No. 3 feet. We stand appalled at the idea of it.

When George Washington got married he had his future pretty well mapped out. He knew what he wanted and was going for it.

It wasn't a week before his wife began to butt in. She wanted him to become a farmer and go around in his shirt sleeves and with patches on his trousers. She wanted to see him milking cows and pounding oxen and starting off to market with a roll of butter and a dozen of eggs. That was the measure of her ambition, and when George couldn't see things that way there was a coldness lasting a fortnight.

Great Scott, but suppose that Washington had given in! Suppose he had been a man without an iron jaw! Suppose he had laid aside his aims and ambitions and gone to raising squashes and pumpkins and gathered a family supply of catnip in the fall! I see the most of you are pale faced and trembling at the thought. Had he done so this country would have had no father. It might have had no liberties.

What name stands out on the Declaration of Independence like that of

John Hancock? He was a gilt edged patriot from the first. Mrs. Hancock wanted the colonies to be free, but she didn't want John's coat tails burned in the doing of it. When he started for that meeting in Philadelphia that was to result in a cataclysm she sought to keep him back. She finally threatened to go home to her mother if he went to Philadelphia, and what was his reply? You may have never read it, as a great many historians have deliberately left it out of their pages, but it has come down to me from an authentic source. He told her just what any patriotic husband should tell his wife under the circumstances. I have a picture of him in my mind's eye as he stood facing her. As she gives him her ultimatum he draws himself up, folds his arms, and, looking down on her with the pride and scorn of a king, he replies:

"Then go and be hanged to you!" He went to Philadelphia and signed that declaration and got others to sign it, and you know the result. Suppose he had stayed at home and gone buckeberrying instead!

When Fulton began working on the steamboat that afterward voyaged on the Hudson and revolutionized the world's transportation, Mrs. Fulton told him that he was wasting his time. 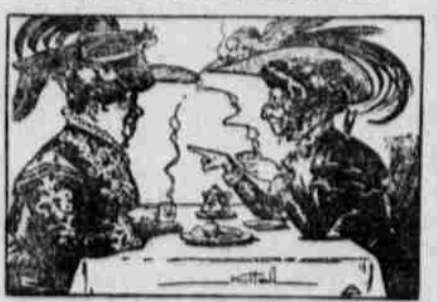
