CLEVELAND PRAISED TAFT

No one questioned Grover Cleveland's fealty to his party as he was loyalty itself to that or organization. Therefore when he stepped outside the narrow limit of patriotism he did a few days before his death to make the following commendation of Mr. Taft it meant something that every thinking American should ponder upon long and well.

There is fear on my part of being misunderstood on what I am about to say but surely the fair minded man must realize when he considers my attitude toward my own party all was a matter of immutable record that it is prompted by a sense of simple fairness. Personally and officially I have had the opportunity of knowing many things concerning Mr. Taft that were not a matter of general knowledge and with a keen interest I have watched his large share in the conduct of our national affairs in very recent years. His excellence as a federal judge in Cincinnati is something not to be underestimated or over emphasized should he come to the presidential chair the qualities which made him a judge of high ability, which I know him to have been, will be most useful to him as president of the United States. His high ideas of honesty and of relative justice, his great capacity for severe labor, and his humanitarian wisdom in the face of the serious problem are attributes equally valuable and commendatory to a people seeking him in whom they may repose the trust of their collective interests while they turn their increased attention to their passing individual demands.

STATEMENT NO. 1 IN NEVADA

By an agreement entered into early in the month the Democratic and Republican State Central Committees of Nevada bound the Legislative candidates of both parties to abide by the popular vote for United States Senator. This agreement was made after Senator Francis G. Newlands' challenge to Senatorial Candidate Patrick L. Flanagan that the choice for the high office be left to the people had been accepted.

For the first time in the history of Nevada, then, the United States Senator will be chosen by direct vote. Peter J. Sommers, Democratic State chairman, and Harry J. Humphries, Republican state chairman, made the agreement binding by affixing to it their signatures.

That no "duke" shall occur in the plans of the candidates, the central committees in joint conference agreed that "hold-over" Senators be bound to Newland's agreement.

All of which shows that the Oregon idea is bearing good fruit.

RESIGNS AS ELECTOR

The executive committee of the Oregon Democratic State Central Committee completed its electoral ticket by naming August Huckenstein of Marion county, Presidential Elector to succeed Bernard Daly, County Judge of Lake county, who was elected by the State Convention, but failed to qualify.

With regard to the above item The Examiner interviewed Judge Daly, who informed us that he had resigned as elector as he felt that all his time belonged to the people of this county, and beside, he considers it very impolitic for him to take active parts in politics, inasmuch as he

was elected County Judge on a non-partizan basis.

The Judge devotes almost his entire time to County Court business and in support of this fact, the County records show that he has never been absent from a special, regular or call meeting during the six years of his incumbency of the office of County Judge, which is a very unusual and a very good record.

The Managers of the Golden West and American Industries Exposition, to be opened at Earls court, London, May 1st 1909 and continue for six months have asked the co-operation of Oregon through Governor Chamberlain. It is the first industrial exposition of this character held since 1887. The business carried on between the United States and the United Kingdom comprises one fifth of the entire commerce of the world, and it is constantly increasing. It is expected that this exhibit will bring together all the present day achievements in science, invention, handicrafts and trades in the United States.

The Wright Bros' aeroplane met with an accident the 17th inst., at Ft. Meers, Va., in which Lieut. Selfridge, of the U. S. army, was killed and Orville Wright had his hip fractured and otherwise injured. It is thought he will be out in six weeks. Some part of the machinery broke off the aeroplane and in the air, rendering it unmanageable, and dashed it to the ground with such fatal results.

It was too bad this accident should have occurred, after so many successful flights. It shows that the flying machine is not a reality yet. But, like everything else, success doubtless will come from failure and experiment.

According to Senator Beveridge, Mr. Bryan has never handled a single foreign problem, has governed no Philippines, regenerated no Cuba, built no canal, avoided no alien danger, saved us from no threatened peril. In domestic affairs Mr. Bryan has written not one law, administered not a single department, advised no president—while lecturing all. He is a preacher of righteousness, but not an administrator of affairs. Mr. Bryan is an Aaron not a Moses; a Henry but not a Washington; a Wendell Phillips, not an Abraham Lincoln.

The Maine elections are not at all satisfactory to the Republican leaders, showing a loss of 4000 votes over that of four years ago, while the democrats show a gain of over 13,000 votes covering the same period. There is no accounting for these figures unless the young men, first voters are all going Bryanwards. If the old slogan, "As goes Maine, so goes the Union," holds good these days, the republicans have got to get to work earnestly from now on to election day to count fact such tendency.

The picturesque J. Adams Bede, Minnesota Congressman, he of the "birch-bark pants" was snowed under in the Duluth primaries last Thursday. He formerly was a democrat, but took up the cross of gold against Bryan and thereby got to congress. His fondness for our Uncle Joe Cannon, and neglect of the interests of his district, compassed his defeat. He was noted more for his humor than for constructive statesmanship. His defeat leaves no one now to occupy the seat of "Sunset" Cox as house humorist.

The Oregon athletes who have just returned from London, called upon the president. He greeted them cordially and said: "My boys, I am proud of you not only because you scored so splendidly at London, but also because you are of our great West. I wish you to convey my heartiest congratulations to Oregon and your fellow citizens, and I sincerely trust that your state will keep up the great record she has made in athletics. Good-bye and good luck."

Three thousand men are walking the streets of Fairbanks, Alaska, with no money, nothing to eat, and no place to stay. HAY PRICE PROHIBITIVE

Messrs. Miller and Gree Will Ship Cattle from Reno

The high price of hay in Klamath county is causing stockmen to go elsewhere for feed preparatory to shipping. F. M. Miller and F. M. Green, of Lakeview, who went there to buy hay for 3,000 head of cattle were asked \$8 to \$8.50 per ton, which price they considered prohibitive and have since made arrangements to ship from Reno instead of Ashland or some other point on the main line, as was their intention.

VANDALS SHOOT INTO A CHURCH

Prineville, Ore., Sept. 14—Two men, whose names are known by prosecuting Attorney Bell, who recognized them as they fled, at 1 o'clock in the morning fired two charges of buckshot through the large and costly stained glass windows of the First Methodist Church in this city. Two windows were completely shattered the buckshot lodging in the ceiling. Part of a third window was broken by shot which glanced off an unseen beam. The offenders were drunk at the time, which accounts for their bungling work and recognition by Mr. Bell who lives across the street, when they ran away.
