"Human instinct, which guided the cyclist, asserts itself to the same or a greater degree with the chauffeur. A wonderfully good pair of eyes have helped in my success as a driver.

"Judge of speed and the marvelous accuracy in estimating the comparative width of the opening and relative width of the car he is driving will enable the driver to pass through safely when the wheels may graze. Every driver knows almost positively just what his car can safely do on a dangerous turn.

"Strength counts for very little in a driver, but rather nerves, quickness and endurance. Speed in a car frequently may avert an accident, as the driver, having his car at its highest speed, seems to be almost able to lift the front of the machine and place it away from danger. To hesitate even for the fraction of a second at such a crisis might mean death."
