



HOUSEHOLD HINTS.

A clear soup contains but a small amount of real food. Its value is in its power to stimulate the flow of gastric juice and to sharpen the appetite for the feast to come.

A certain housewife sometimes serves frozen chocolate, which is merely the morning beverage frozen to a mush in the freezer. Serve in sherbet glasses, with a spoonful of whipped cream in each glass. Her rule for the beverage calls for two squares of chocolate, a cupful of sugar, a few grains of salt, a cupful of boiling water and three supfuis of rich mllk.

A delicious way of using left over fish, such as weakfish, bluefish and others, is to flake the flesh, removing all bones, then let it come to the holling point in a nicely made cream sauce seasoned with cayenne and flavored with parsley and diced onion. Pour It N after seasoning over several moist slices of teast and decorate with points of tonst and sprigs of fresh parsley.
