



C., Jan. 7. -Senator Chamberlain has introduced a bill for the protection of water power sites, the purpose being to prevent private corporations from ob-taining permanent title to them. The bill in all details as rees with the Roosevelt power site policy. It pro-vides for leases for thrity years and application fee of 10 cents per horse power, and an established water fund; and an annual liscense of from one-half of 1 per cent to 1 per cent of the gross receipts, readjustable at the end of each ten-year period. 
