Salem. Ore.. Jan. 23.-The lower court of Jackson countr was reversed by the suoreme court today in bv the suareme court today in the 81 . coversed $500,000 \mathrm{zood}$ road bond issue. The bond issue is thus knoeked out. In an obinion bv Justice Burnett.
