# Sugar Beets Shipped

Three cars of sugar beets brought in to Reno by the N.-C.-O. railroad and transferred to the Southern Facific for Fallon bring the total shipment of beets handled by the N.-C.-O. from points along its line to about sixty cars this season, says the Reno Journal.

Most of these beets have been shipped from Madeline and Amedee and exceed the record of past years by a number of cars.

Agents of the N.-C.-O. stated last night that they believed these cars practically finish the beet season, as the harvest has been completed for some time and the product has teen hastened to the factory as itast as the railroad has been able to handle it.

According to the figures in the Sparks office, the Southern Pacific will han'lle in all about 200 cars of beets this year.
