Free Beet Seed

The Examiner has for free distribution among farmers some sugar beet seed that is being furnished by the N. C. O. Railway in an attempt to ascertain the possibility of producing such a product in this valley. The only qualification that goes with this offer is that the farmers return a few of the beets to this office after they are matured so a test can be made of their sugar quality. These planting the seed are asked to put them on an average piece of ground, not selecting any particular choice spot.

This will prove a profitable experiment for farmers as the beets make choice stock food and can be utilized for this purpose as well to prove their adaptability to this climate and soil.

Below are given a few instructions in regard to planting and cultivation:

Notice to Sheepmen

On account of wildfire in the sheep in this county all sheep in county must be dipped once before they can get a clean bill of health to enter the Forest Reserve. This disease appears to be of an infectious nature and is spreading throughout the county. With the aid of a mild dip it is thought the disease can be suppressed.

Harrison R. Albee will be Portland's first mayor under the commission form of government adopted at the charter election held June 2. His election is conceded by A. G. Rushlight, the present mayor and runner-up in the election. None of the other candidates for the mayoralty approached Albee and Rushlight in the number of votes received.

Besides voting for mayor, the electorate chose four commissioners and an auditor. The newly elected officers serve for four years, but are subject to recall. The mayor will draw a salary of \$26000, while the four commissioners draw \$5000 each.

Nearly 80 candidates sought election as commissioners and there were four candidates for Mayor.

LAKEVIEW SCHOOL HAS BANNER YEAR

Report Shows Large Attendance--Good Work Accomplished

After what was considered the most successful term ever taught in this county the Lakeview High and graded schools closed last Thursday. The final week was well filled with programs and closing exercises and the accomplishments of the year were considered good from every standpoint.

The annual report made out by City Superintendent O. M. Gardner shows that the number of pupils on the register since beginning of the year marked "R" were 165 boys and 178 girls, making a total of 343; total number marked "E", 14 boys, 17 girls, total 31. Total number of pupils on register over 6 years and under 9, boys 42; girls 46, total 88; over 9 and under 12, boys 46; girls 39, total 85; over 12 and under 14, boys 24; girls 33, total 57; over 14 and under 20, boys 53; girls 60, total 113.

Number of days taught during year, 171; Whole number of days attendance, 49,260; whole number of days absence, 1,436 1-2; whole number of times late, 516; Average number pupils belonging, 297; average daily attendance 288; per cent of attendance 97; number visits by parents, 81; number of visits by school board, 12.

Those of the old faculty who have been retained by the board to teach next year are:

O. M. Gardner, superintendent; Mrs. Eva Gardner, domestic science; Miss Fletcher, 8th grade; Miss Knight, 7th grade; Mrs. Pauline White, 6th grade; Miss Mable Snelling, 5th grade; Miss Bessie Burgess, 4th grade and Miss Gertrude Vernon and Miss Pearl Hall, 1st and 2nd grades.

John Garrison, of Kansas has been selected for manual training, as have been Marie Church of Corvallis, teacher in high school and Miss Lou Hostetler also of Corvallis for the third grade. This leaves two vacancies yet to be filled.
