Samuel Hill, the world-famous good roads man of Maryhill, Washington, accompanied by Messrs. Lockley and Johnson of the Portland Journal, were in Prineville Monday night. These gentlemen have just completed a tour through Central Oregon for the purpose of viewing out an automobile road which will ,connect with roads in California and Washintgon that will give an all the year around road for auto tourists from Southern Califor-

nia to the Canadian line. They were slad to report that they had been successful. The proposed road sarts at Biggs, coming up through Wasco and along the backbone of the divide between the Deschutes and the John Day rivers of Shaniko, down Antelope canyon, through Trout creek and Hay creek, up Mud Springs canyon to Lamonta, thus avoiding Grizzly mountain to Prineville, thence south past Millican over the desert to Lakeview.

No part of this proposed road will have over a 5 per cent grade and can be built at a less expense than any through route in any other part of the state. Roads already exist along this route which can be put in shape for use at a very little expense until such a time as a permanent road can te built. The object is to make this an International highway and have it built under the supervision of the Oregon Commission. Connection can be had temporarily by ferry with the Washington road and eventually it is the plan to tridge the Columbia from Biggs to Columbus. At Biggs also this road will connect with the road which is being built up the Columpia from Portland.

Build From Lakeview To Susanville.

The following railroad goesip is taken from the Sacramento Bee's 'Looking Westward'' edition, which is considered as one of the most reli-

The most important of the two new steam roads is the Fernley and Lassen, which has been completed from Fernley, Nev., to Susanville, Lassen County, and is pushing on to Westover, a new lumbering town that is being built by the Walker interests of Minnesota, and which is to have a population of about 5,000 in another

year or two. This is the first railroad to reach Susanville and it is causing a great change in the affairs of the whole country. It will do still more good, however, when it is extended on westward to a connection with the railroads of the Sacramento Valley, giving a direct, instead of a round about route to Sacramento and San Fransisco. The route for the extension to the Valley will bring it to Vina, Tehama County, or to Chico, the latter city having been making strong efforts to induce it to make its junction there. The road is a branch of the Southern Pacific.

The same road is planned to connect with other proposed roads of the same w. F company that sre to be built from Lakeview, Oregon, through Alturas, and from Klamath Falls, Ure., southwesterly and southeasterly, respectively, and to form a junction at Lookout, Modoc County. This project will give the northeastern counties of California a much needed system of railroads and lead to immense development of vast latent resources. It is a country of great possibilities, but its remoteness from railroads or other adequate transportation facilities has prevented its development.




