LYNCHING IN SOUTH GO MERRILY ON AS CONGRESS FAILS TO PASS LAW

States Enjoy Their "Rights" To Put To Death Victims Without Lawful Trial.

(Special)

New York, N. Y. Jan 14—The National Association for the Advancement of Colored People, 69 Fifth Avenue, has received word of a lynching on December 31, 1926, at Waldo, Florida, which brings the total for the year 1926 to 34, instead of 33 as reported.

The lynching victim was George Buddington, wood-chopper, who, it is reported, had contracted to chop wood for a white woman at a specified price. When he had done the work she offered him a smaller sum of money. An argument ensued. The colored man was accused of "insulting" the white woman in the course of the argument and was lynched by a mob of white citizens.

Charged with "planting" human bones in his home near here and then burning the house down as evidence that he had perished in the flames so that his wife could collect a \$7,500 insurance policy, Harry K. Sligh, supposedly dead since last September 27th, has been arrested in Los Angeles, Calif., very much alive.

Nashville, Tenn. Jan. 8.—Over 1,000 members of the Negro race are homeless as a result of the most devastating flood in the history of this city.

The Cumberland River ruthlessly sweeping through Nashville has spread over a wider territory, leaving inundated homes, and crippled transit facilities in its wake. The loss suffered by the colored people is estimated at \$100,000.

Famous Violinist

Miss Hansen has been called the greatest woman violinist of the age, but it is not only as a woman violinist that she invites comparison.
