

But th fact is, America has. And while a reversal will not change that jury's opinion in the least, it is our duty to get freedom, nothing short of it, for those nine innocent, helpless Negro boys. It will take a long time to educate those Alabama whites to the point where they can think clearly regarding a Negro and citizenship rights and that they are human with the same rights as they themselves enjoy.
