First Boat on Crater Lake.

To David Linn of Jacksonville belongs the undisputed honor of having launched the first boat on Crater Lake. This event took place on the afternoon of Thursday, August 5 1889, when the boat was launched and a party composed of Mr. Linn, Lieutenant Small, from Fort Klamath, James D. Fay and James Sutton of Jacksonville took the first boat ride ever made by man on Crater Lake, for the few white men who had visited it previously had no boat or other means of navigating the water of the Lake, and the Indians certainly had not for they had such a horror of the great hole in the top of the mountain, thinking it the abode of evil spirits, that they gave Crater Lake a wide berth in their travels. Mr. Linn and his party visited Wizzard Island that afternoon, being thus the first persons to visit that wonderful volcanic cone. They climbed to the top of it and brought away as souvenirs pieces of pumice and lava rock of which the cone is formed. Mr. Linn yet has two of the pieces, one being a dark-colored pumice stone.

Mr. Linn built the boat, which was scow-shaped, 16 feet long and 3½ feet wide, at his planing mill in Jacksonville but did not put it together here leaving the boards separate and hauling them to Crater Lake. The morning of the day that they made their voyage on the Lake they carried the boards down the rugged precipice leading to the water. They had a very hard time getting down to the water's edge for there was no marked out trail and several times, being encumbered with the boards, they were in imminent danger of losing their footing and plunging down into the Lake. Arriving at the water's edge it was but the work of a short time to put the boat together and soon the waters of Crater Lake were broken by the splash of oars for the first time since that wonderful body of water was formed. Mr. Linn's party remained in camp at the lake for several days during which they fully explored the lake in their boat. When leaving the lake they took the boat and placed it in a sheltered place on the bank, posting up a notice on the trail telling where it could be found and requesting those using it to return it to its place where it would be sheltered during the winter months from the weather. As to what ever become of the boat Mr. Linn does not know and as it disappeared long years ago it is probable that some careless, lazy party used the boat on the lake and leaving it in the water the winter storms wrecked it.

The first picture ever made of Crater Lake was by Peter Britt of Jacksonville. Mr. Britt, accompanied by his son Emil, who was then a small boy, and Samuel Hall, in August 1874 made a trip to Crater Lake for the purpose of taking a picture of the lake, for none had ever been made before, as no other photographer was venturesome enough to undertake so tiresome and expensive a trip as it then was. The road then was more difficult to travel than now and to haul to Crater Lake their camp outfit and a complete photographic outfit was a big undertaking for that was before the dry process had been invented and Mr. Britt had an outfit that weighed over 200 pounds, for he had to use the wet process and to take with him a full supply of chemicals, silver baths and other helps and prepare each plate as he used it. Mr. Britt put in the greater part of two days in taking views of the lake and he succeeded in getting seven negatives some of which he yet has. The first engraving to appear in a publication was made from a photograph supplied by Mr. Britt and was in the West Shore an illustrated magazine published in Portland some years ago. Mr. Britt, who is a painter of considerable talent, painted in oil a fine sketch of the lake which was the first ever made of the celebrated scene. The painting yet hangs in Mr. Britt's studio and it compares well with those painted in later years by other artists.
