

A Fatal Shooting Accident.

The Ashland Tribune gives the following account of a hunting accident that resulted in the death of one of the parties: George W. Woody, a well known rancher residing down the valley, near Phoenix was fatally shot by his companion, James Daily, while hunting near Grizzly Prairie about 30 miles east of Ashland in the Dead Indian country last Friday.

Woody lived about fifteen minutes after he was shot. The body was brought to Ashland, arriving here Saturday evening, by Miller Sutton, accompanied by the widow of the deceased, her two sisters, Misses Julia and Frances O'Toole, of Phoenix, Oscar Stinson, and James Daily. All except the latter and Mr. Sutton comprised a pleasure party which left the Woody home Tuesday for a trip to Crater Lake by way of Pelican Bay and expecting to return by the Rogue River route. The remains were taken to Stock's undertaking establishment and Coroner E. B. Pickel was summoned from Medford.

Dr. Pickel held an inquest Sunday morning. The jury was composed of W. E. Phipps, P. D. Wagner, W. J. Booth, H. C. Sheets, R. S. Stephens and Chas. O. Bishop. Daily's testimony, which is substantially confirmed by that of Oscar Stinson, and covers all the facts developed in the case, is as follows:

James Daily, 35 years old, a resident of Dead Indian, postoffice Ashland, occupation, farmer, testified: Have known deceased George Woody about one year. On the 11th of September, 1903, George Woody, Oscar Stinson and I started out hunting from Taylor's ranch, Dead Indian, about 8:30 a. m., on horseback, going about five miles to a high cliff, tying our horses at the base of the cliff on top the ridge, we all went to the top. Separating, George Woody went around the point in one direction and I the other, Stinson remaining on the summit. I had gone nearly a quarter of a mile and a deer jumped up about 100 yards away. I shot at it and after it had made several jumps I shot again when I heard Woody shout. I could not see him at once but soon he came running out of the brush toward me, calling out, "Oh my God, I am shot through the heart." I ran to meet him and when I reached him he threw his arms around me telling me to keep cool. I then called for Mr. Stinson to come quickly. George Woody told us to stop the blood if we could and I pressed my hands over the wound to stop the bleeding. He called for water and as there was none near by he said he believed he could ride. I got his horse and with a little assistance he climbed on, Mr. Stinson getting on behind to steady him, and I walking and leading the horse. We went about half a mile when Woody said he could ride no longer and we would have to help him off. I then mounted my horse and started for Mr. Sutton's place two or three miles away, the nearest ranch. Reaching there I told him what I had done. He took a stretcher and some whiskey and I went on home to tell his wife and get some more whiskey. I then went back to where Woody was and Mr. Stinson told me that he, Woody, had died about five minutes after I had left him. He died about one o'clock.

I supposed Woody was on the other side of the hill when the shots were fired. It was about a half hour after we had separated. When I saw Woody come out of the brush he was about 150 yards away. I did not see him at the time when I shot. I don't think I killed the deer. It was a buck deer.

The jury returned the following verdict:

"The undersigned members of the coroner's jury summoned to sit at said inquisition find that the deceased's name was George Washington Woody, that he was 24 years of age; that he came to his death in Jackson county, Oregon, Sept. 11, 1903, from a gun shot wound in the left breast which cut the sub-clavian artery; that the gun from which said shot was fired was in the hands of James Daily. We further believe that the shooting was purely accidental and no blame attaches to anyone for said accident unless it be a possible carelessness or lack of cautiousness on the part of both parties concerned."

The remains were taken to Medford Sunday afternoon and the funeral took place there Monday afternoon under the auspices of the A. O. U. W., of which the deceased was a member. He was a young man highly esteemed among his neighbors and was conducting his mother's farm. Mr. Woody had joined the Workmen in June and paid but one assessment. His wife, who was formerly Miss Catherine O'Toole, will be paid the full amount of his certificate of \$2000 about the first of October.

SUMMONS.

In the Name of the State of Oregon: You are hereby required to appear and answer the complaint filed against you in the above entitled Suit within ten days from the date of the service of this Summons upon you, if served within this County, or if served within any other County of this State, then within twenty days from the date of the service of this Summons upon you; and if by publication, then on or before the expiration of six weeks from the commencement of such publication and if you fail so to answer for want thereof, the plaintiff will take a default against you, and will apply to the Court for the relief prayed for in her complaint, viz: For the dissolution of the marriage contract now existing between the plaintiff and defendant, and for the award to plaintiff of the care and custody of the minor child of said parties, and such further relief as to the Court may seem equitable.
