Precipitation, total 10.64 inches; greatest in 24 hours 1.82 inches on the 14th; snow $\frac{1}{4}$ of an inch. No. days with .01 inch or more precipitation, 19; clear 2; part cloudy 3; cloudy 25. Killing frost on the 17th. Total precipitation for season 11.19 inches; same last year 7.45 inches. The precipitation for November is the greatest on record at this station for any month for the past 20 years.
