Candtdates for Judge and Commissioner Declaring in Favor of Good Roads-The Socialists to complete Their Ticket More Candidates in the Field.

Jacksonville will have eight delegates in the Republican convention and but two delegates in the Democratic convention. Capt T. J. West, a well known farmer of Brownsboro, has come out as an active candidate for connty commissioner on the Republican ticket. Capt. West is a strong advocate of good roads and he has written many forceful articles for the Jackson county papers on good road topics and he proposes to make his campaign on the good roads issue, he favoring macadamized roads built according to the best methods in use. To accomplish these results he would have the county purchase a steam road roller that is a combination roller, traction engine and stationery engine, enabling it to be used for rolling roads hauling the rock crusher and for operating the crusher.

It will require 67 votes in the Republican county convention to nominate as the convention will be composed of 133 deligates. The Democrats will have a much smaller convention, they having been one of strenuous times and anxious but 67 deligates, which will require 34 votes for a nomination.

The annoncement was made in the Sentinel of last week of the candidacy of Peter Applegate for county judge. As to his candidacy Mr. Applegate states that he not formally announced himself as a candiate for county judge on the Repuplican ticket, but if he should it would be on the good proposition and to let the county debt stand for a few years while roads could be built. But he may not seek the judgeship and may be a candidate for assessor, as many of the leading Republicans are urging him to take this nomination. The report is out that Ashland and Medford Republicans have made an alliance whereby they will support each other's candidates in the convention and in the campaign. The principals in this deal are said to be Capt. J. E. Thornton, Ashland's candidate for sheriff, and Geo. L. Davis, Medford's candidate for clerk. Capt. Thornton served in the Second Oregon in the Philippine campaign and he is popular with the old soldiers and business men of his acquaintance. Mr. Davis is of the firm of Warner & Davis, one of the leading business houses of Medford and he has a high standing in the business community. With two such men pitted against Sheriff Rader and County Clerk Orth, who are two of the most popular officers Jackson county ever had the contest for sheriff and clerk will be the livliest part of the campaign.
