Death of Mrs. Theo. Cameron.

The many friends of ex-Senator and Mrs. Theo. Cameron were shocked last Saturday evening to learn that Mrs. Theo. Cameron had died that afternoon at Klamath Falls, where she had gone two weeks previous to assist in caring for her daughter-in-law, Mrs. Otis Krause.

Mrs. Cameron, was not feeling well when she left Jacksonville and the strain and overwork incident to caring for Mrs. Krause and for Mr. Krause, who was also sick for several days, brought on a fever and on Tuesday of last week she was confined to her bed. She soon became quite sick and Thursday the ladies of the Eastern Star, of which she was a member, who were assisting in caring for her, removed her to the residence of Mrs. Beals to avoid the confusion incident to having two sick persons in the same house. Friday Mrs. Cameron was much worse and declared to the attending physician that something serious was wrong with her bowels. So serious did her case become that Saturday morning Dr. G. W. Maston decided that she was afflicted with strangulation of the bowels and with the assistance of Dr. H. B. Hargus he performed an operation and found a loop in the intestines caused by an adhesion the result of an operation some years previous for the removal of a tumor. Mrs. Cameron did not rally from the operation and at 3 o'clock that afternoon she succumbed to the shock. The body was placed in a casket and that evening was placed in a vehicle for conveyance to the railroad station at Pokegama, arriving Sunday noon in time for the train to Laird, where it was transferred to the Southern Pacific and brought to Medford.

Mr. Cameron had received word Friday evening of the serious illness of his wife, but too late for him to go on the evening train and Saturday morning he started for Klamath Falls and on reaching Laird received a message that Mrs. Cameron was dead. He went to Pokegama and met the body and escorted it home. A message had been received in Jacksonville that Mr. Cameron would arrive in Medford at 11 o'clock Sunday night. A special car was chartered and a number of Masons, Eastern Stars and friends went to Medford and assisted in bringing home the body of Mrs. Cameron and of giving to Mr. Cameron comfort and encouragement in the hour of his bereavement. Undertaker and Mrs. C. W. Conklin embalmed the remains and made preparation for the funeral, which took place Tuesday at 1:30 p. m. The services were to be at the cemetery and to be conducted by Adare! Chapter No. 3, O. E. S., and by Ruth Rebekah Lodge No. 1, both lodges of which deceased was a member, but the very inclement weather of that day made that plan inexpedient and the casket was taken to the Masonic hall where the beautiful and impressive burial service of the Order of Eastern Star was carried out. The large hall was crowded with the friends of the deceased and the floral offerings were many, several being beautiful emblematic designs. At the close of this service the casket was escorted to the cemetery where a brief but impressive service was held by the Rebekahs, the weather not permitting of the full burial service of the order.

In addition to a large concourse of persons from Jacksonville and vicinity there were many present from a distance, those from Medford being Mrs. J. A. Whitman, Mr. and Mrs. H. U. Lumsden, Mrs. W. H. McGowan, Mrs. C. I. Hutchinson, Mrs. J. D. Heard, Mrs. L. L. Jacobs, Mrs. Ivan Humason, Dr. and Mrs. W. L. Cam-

eron, Mrs. J. E. White, Dr. J. M. Keene, Mrs. Mox Muller, Wm. Muller, J. E. Enyart, Mr. and Mrs. M. H. Hanley. Those from Applegate were R. J. Cameron, Z. Cameron, Wilbur Cameron, P. Swayne, Mr. and Mrs. H. D. Kubli, Hon. and Mrs. Miles Cantrall.

Mrs. Cameron, whose maiden name was Mary Bilger, was born in Selkirk, Ontario, Canada, February 16, 1859. Her parents dying when she was a child she was taken to Buffalo, N. Y. and resided with an uncle, until 17 years of age when another uncle, John Bilger a resident of Jacksonville, on a visit East brought Miss Bilger to Jacksonville. In 1879 she was married to Frank Krause, then publisher of the Oregon Sentinel of Jacksonville. He died some years later Mrs. Krause being left with three little children, who are now Mrs. Ella Lang, of Oakland, California, Otis Krause of Klamath Falls and Miss Margaret Krause of this place. In 1892 Mrs. Krause was married to Hon Theo. Cameron and one son Donald is of that marriage. Mrs. Cameron was a noble, generous woman, of a kindly, happy disposition, who made the world the better for having lived in it and her death in the prime of life is a heavy blow to her bereaved husband and children, a most serious loss to the community at large and her cherry, helpful presence will be sadly missed in the various walks of life that knew her. Mrs. Lang was present to attend her mother's funeral, but Mr. Krause was kept in Klamath Falls by the continued illness of his wife, who is now slowly improving. Mr. Cameron and the family express their heartfelt appreciation of the sympathy and thoughtful kindness that were rendered to them by friends in their time of sorrow and loss.

but that work wite a full crew was being carried on at each of the three mines, the Oro Grande, Missouri and the Greenback. Al Shearer is superintendent of the three mines. Two No. 3 giants are in operation at the Oro Grande and one No. 3 at the Missouri. The bad weather has delayed getting the giants in place at the Greenback of which there is to be two large ones. It is expected to have these in place within two weeks as the ditches are completed and everything in readiness. The Company has a sawmill at the Oro Grande and it is being run steadily cutting lumber for more flume boxes and for additional houses at the three mines. Both J. D. Heard and J. A. Whitman of the Oro Grande Company are at their homes in Medford, where they will remain for a couple of weeks when they will return to their mines.

T. C. Norris arrived back in Jacksonville Tuesday for the first time in the month since he moved to Medford. No sooner had Mr. Norris got settled in Medford and had opened up his real estate office than he was taken with the smallpox and confined to his home for three weeks. Last week he was released from quarantine, but now his family are under quarantine and he can not go home, so he is putting in his time here in Jacksonville pushing sales in his store. As to his plans he has not decided whether he will move his store to Medford or let it remain in Jacksonville. He will continue though in the real estate business with an office in Medford.

At the January term of circuit court for Josephine county the jury in the case of E. L. Dunham vs. the S. P. Co. award the plaintiff \$12,000, damages. On motion Judge Hanna several weeks ago granted a new trial, assigning as a reason therefore error is giving the jury an instruction asked for by the plaintiff's attorney. The court holds that under the law and evidence in the case the plaintiff although under age is held to the same degree of responsibility in looking out for himself and avoiding personal danger than an adult would be. The instructor referred to was the reverse of this and therefore clearly misleading upon the main issue in the case, viz. the negligence of the parties. The case will come up again for trial at the April term of circuit court at Grauts Pass.

The big freshet in February tore out the Jackson creek bridge and so washed out the roadway and the Central Point road that it has since been impassable to teams. As one freshet has succeeded another during this winter of extraordinary weather conditions it was next to impossible to get the road repaired but so great is the necessity for this road being open to travel that the county court has determined to have the necessary repairs made at once and Monday Judge Prim and Commissioners Patterson and Riley were down and looked over the situation. The court found that the road in the vicinity of the Jackson creek bridge is so badly washed out that it would be a very expensive job to fill it in and to rebuild the bridge and then it would not be permanent, for this section of road was badly washed out last winter and to repair it cost the county a couple hundred dollars. To obviate all future trouble to the road the court has decided to let the creek have that section of the road and they have arranged with Col. Maury and Mr. Bursell to set their fences back four rods for a distance of about 80 rods and give a road bed, the county to pay them for the land. County Surveyor Jones made a survey of the new route this week and it is expected to have the road open to travel next week.
