## Republican Campaign to be a Captains' Fight-More Candidates in the Field and Some Decline-Socialists and Local **Optionists** Open Their Campaign.

Joe A. Thomas, candidate for representative on the Socialist ticket, has evidently heard of the early bird catching the worm, so he is getting afield early to catch the voter. As a campaign opener he is sending broadcast over the county a card bearing his name and the following outline of the principles of the Socialist party: "Well, what do you Socialists want?" "Well, we want to stop dividing up. Can you suggest any way to do so, under the present system of private ownership? In your miud, turn this over. The Plan, Demands and Methods of the Socialists are: Demands-(1) the right of daily labor for every human being; (2) full credit for all that is earned by each human being; (3) a home for every human being. Methods-(1) ownership of the means of production and distribution by the people; (2)management of each industry by the workers therein; (3) credit for hours of labor and debits for supplies drawn. Results-national co-operative conduct of business and economic salvation of the world. There shall be equal opportunities for all and no man shall live by the labor of another and none possess what he has not earned."

There is a strong feeling among Republicans that their candidate for county judge must pledge himself that if relected he will be at his office during office hours and not at the courthouse but one or two days in the week. The county is now so large and there is such a volume of business to come before the county court that it is imperative that the county judge give his full time to the duties of his office. To have a county judge absent half the time would cause much expense and inconvenience to persons from distant parts of the county coming to the county seat should they not be able to meet the judge promptly. One of Judge Prim's strong points is that he resides at the county seat and is in his office much of the time

Recent developments indicate that the Republican campaign now on in Jackson county is to be a captain's fight, to use a naval phrase, and no word of command is likely to be heard from the admiral and commodores of the party. Admiral Ankney and Commodores Vawter and Carter are each on self-issued leaves of absence from active campaign duty and are permitting the captains to exercise full control of the party forces and if they fail to lead the ticket to victory they can lay the fault to no one but themselves and not the party leaders as was the case two years ago when half of the ticket was put out of action by the Democrats.

On Saturday of next week will accur the Republicans convention in Ashland for electing delegates to the congressional convention at Salem, and the state con-vention at Portland, Jackson county is entitled to 12 delegates in each convention and the apportionment of these delegates to the various sections of the county is now being figured on by the powers that be. The apportionment likely to be adopted for the congressional convention will be to give Ashland 3, Medford 3, Jacksonville 2, Applegate 1, Gold Hill 1, Eagle Point 1, Central Point 1. For the state convention this apportionment will probably be changed if there are demands by other precincts for recognition and to give Talent Brownsboro, Wellen and other places delegates.

As the Salem convention is on Wednesday, April 13 and the state convention in Portland on the following day it was thought that one set of delegates would suffice for the two conventions but so many desire the honor of the trip, even though they pay their own expenses that it is quite certain that two full delegations will be chosen- Ashland and Medford each have so many candidates that the Sentinel will not attempt to enumerate them least half a dozen be over looked. Jacksonville is more modert and has but four candidates, Dr J. W. Robinson, Theo, Cameron, Emil Britt and W. G. So far Henry Kubli has the Kenney. Applegate field to himself. Gold Hill has two candidates, C. Vroman and G. H. N Allen, editor of the Gold Hill News.

On Saturday of next week the Democrats will hold their primaries and on the following Saturday their county convention at Medford. The Democrats content themselves with one set of primaries and one county convention. On the surface all is as quiet as a Quaker meeting in Democratic circles, but it is not the stillness of inaction, but quite the reverse for the Democratic leaders are doing some adroit scheming to enable them to win out in the coming campaign against a Republican plurality of 250.

The lateness of the date on which the Republican county convention is to be held at Gold Hill is giving serious con-cern to some of the Republican leaders, they fearing that it may be the means of the party losing some of its nominations. ney subject to the endorsement of the other counties in this district. The Josephine county Democrats will hold their primaries Saturday, April 9, and and their convention in Grants Pass on Saturday, April 16. The Republicans will have 48 delegates and the Democrats 45 delegates in their convention.

Mulkey has announced to those who have been urging him to enter the race for congress from this district, that while he is grateful to his friends who have been kind enough to think of him in connection with the high position, he must decline to mingle with politics di-rectly or remotely.
