Republican Platform.

The following is the platform adopted by the Republicans at their county convention held at Gold Hill last Friday:

First-The Republican party of Jack son county, Oregon in convention assembled, heartily endorses the thoroughly American administration of Theodore Roosevelt and his earnest efforts for the suppression of illegal trusts and merges and for the advancement of the welfare and interes's of the laboring masses, and the advancement of this nation's honor among the leading nations of the world.

Second-That we deprecate the dissensions heretofore existing between persons and localities, which dissensions have made the success of our Democratic adversary possible in Jackson county, and that all Republicans be urged to lay aside personal feeings and prejudices and work for Republican success, from first to last and from the least to the greatest.

Third-We declare for a just and equitable assessment of property for the purposes of taxation, that the tax burden, may be borne in fair proportions by corporations as well as individuals.

Fourth-We declare in tayor of economy in the administration of county affairs and pledge the candidates of the Republican party of Jackson county to use their earnest efforts to accomplish such results.

Fifth-We declare that the best interests and welfare of Jackson county depend in a large measure on the condition of its highways and facilities for rural transportation and we therefore pledge our candidates for county judge and county commissioner to use all reasonable efforts in the matter of the betterment of our public highways along the line of modern principles, without making taxation unnecessarily burdensome.

A large banner inscribed "Republican Headquarters' directs the location so that he who runs may read, while the flag also floats from a staff in front of the room. Inside, large pictures of the martyr President McKinley and of President Roosevelt line the walls and the room is fitted with desks, tables and chairs, telephone accommodations, etc. Chairman Staples puts in much time at headquarters which are in charge of C.
