### BLACKWELL **MINES**

Progress of Work and Development Among the Valuable Properties of the Famous Blackwell Mining District.

### JURY FOR NEXT TERM OF COURT

C. T. Davidson, who is working at the Millionaire mine in the Black well district was home to spend Sunday with his family. Mr. Davidson has been mining in Southern Oregon for more than 20 years and in that time he has not seen the activity in mining that there is here this year. In the Blackwell district, which is a section of several miles northwest of Jacksonville, Mr. Davidson stated that almost every claim in that district is being worked and not prefunctory assement work but substantial development that is showing up many very promising ledges, that makes it certain the Backwell is soon to be one of the richest and busiest mining districts in

Of the progress of development work at the Millionaire mine Mr. Davidson reports that 12 men are employed and that on the main shaft where a steam hoist is used work is carried on day and night. Two other shafts are also being sunk, one on an extension of the main ledge and the other on an adjoining ledge. Only a day shift is employed on these shafts and the hoists are horse power winges. The main shaft is down 160 feet and the others 70 and 40 feet. A car load of ore was shipped some time since and the mill test proved conclusively that the ore in the Millionaire mine is sufficiently rich to warrant the full development of the mine and as there is known to be a large body of mineral bearing rock the Company expect in the near future to erect a ten stamp mill which it is expected to enlarge to 20 stamps within

The old Schump mine, from which considerable gold has been taken in the years past, has been bonded from the owners Huston & Ingram, by E. L. Ellison. Mr. Ellison has two men helping him and he is extending the tunnel to fully develop the ledge and determine its extent and value and if it continues to hold the value now shown he will acquire in full the property and put up a mill.

At the Roaring Gimlet, another Blackwell mine that has produced a lot of gold futher development work is being carried on and there is every prorpect that this mine will prove of sufficient value to warrant the erection of a mill and the handling of the ore at the mine.

parties and is now being worked by a full crew. The mill which is a five stamp, is being run day and night and so profitable is the venture proving that the leasees are planning to add another battery of five stamps to the mill.

In the Willow Springs district, which lies between the Blackwell district and prospecting being done and a number of very promising ledges are being opened up and there is every likelihood that by another several mills will be built in this district.

## Land Districts For Special Agents.

For the purpose of securing a more efficient administration of law under which special agents of the general land office are appointed, Secretary Hitchcock has approved the plan of the commissoner of the general land office to divide the states having government land into nine districis. An agent to be known as the special agent in charge has been designated in each district.

Amony the states comprising the

several districts are the following: First district, Washington, second district, Oregon; third district, California and Nevada; fourth district, Idaho and Montana; fifth district, Colorado, Utah, Kansas and Oklahoma; sixth district, Arizona and New Mexico; seventh district, North and South Dakota, Wyoming and Nebraska. Among those designated as agents in charge and the states from which they hail are the following: First Edward Dixon, Oregon; second, Thomas B. Neuhausen, Minnesota; fifth, Nicholas J. O'Brien, Wyoming.

Headquaters of the special agent in charge will be situated at the United States land office.
