### Methodist Episcopal Conference.

The annual conference for Oregon of the Methodist Episcopal church will convene at Eugene on September 28. The conference will be presided over by Bishop Henry Spellmeyer, resident Bishop at Cincinnati, Bishop Hamilton, resident Bishop at Portland being about in the East holding conferences. The terms of three presiding elders will expire on that date and Bishop Spellmeyer will appoint three new men for the position the conference not exercising this authority, the rule being not to reappoint present incumbents. The elders whose terms expire are Dr. D. T. Summerville, of Grants Pass districts; Dr. T. B. Ford, of the Eugene district; Rev. D. A. Waters, of the Salem districts.

At the last session of the quarterly conference, held at Central Point, it was decided to discontinue the consolidation of Jacksonville and Central Point as one charge and for the next conference to 46. give each of these towns a pastor. The work in these fields has so increased that it was thought that the interest of the churches would best be served to give each a pastor and if the towns are fortunate enough to get suitable energetic men assigned to them there will be no difficulty in securing the necessary financial support for the two pastors. Rev. Sanford Snyder has been in charge of the two churches for the past year but it has been decided that he is to take a new charge and the pastors for Jacksonville and Central Point Methodest churches will not be known until the conference.

H. W. Jackson, of Medford was in Jacksonville, Tuesday on mining business. Mr. Jackson, who with C. B. Various Sections of the County Baker, of Boston, and J. L. Hamilton, of Medford were owners of the Monumental Mine on Shelby creek, which they sold some months ago to the Union Iron Works Co. of San Francisco, stated that the San Francisco people would make their last payment, which is \$25,000, on the 24th of this month. The new owners are pushing the development of their mine in a rapid manner. They now have 45 men at work blocking out ore and erecting buildings doing other work for the installing of a 200 ton smelter at the mine. A large steam hoist, compressor and Burleigh drills are now in place and three four-horse teams and one six-horse team are hauling out Crescent City the remainder of the plant, a part of which is two cylinders, of 100 tons capacity each, to be used in the sweet roasting process for handling the ores, which are base, and have to be roasted before puting through the cyanide process to extract the gold. The plant will be one of the most complete in the West and the mine will employ about 150 men when in full operation. A small town has already come into existance about the mine, 19 houses having been erected in the past four weeks.
