# Medford Saloons Win.

The Medford charter bill went back to the governor Tuesday and was filed by him with the secretary of state without approval. The bill has become a law, and will take effect upon the expiration of 90 days. Amendments to it are now under way in the Senate to eliminate some objectionable features. One of the features of the amended bill will take away the power of the conncil to permit saloons to run on Sunday, but hereafter, the local option law will have no force or effect in Medford.
