## Oregon Timber Wolves.

Giles Hunt, of Oakland, Oregon, recently killed a large timber wolf that measured seven feet from tip to tip, in the hills above Driver Valley, Douglas county. The freocious beast would no doubt have attacked him had he not got in a lucky shot in the nick of time which changed his notion. These animals are becoming quite numerous of late years in Lane, Douglas Josephine and Jackson counties and each succeeding year they venture further into the valleys in larger numbers where their audacious depredations cause much greater loss to farmers and stockmen than those of the cougar. However, their favorite haunts are high up in the heavily timbered ranges of the Cascade mountains where they rear their young and enjoy a venison diet both in season and out. Hunters have often found them sitting on the bank or trotting liesuerly around a pool in some little mountain stream where they have succeeded in running a deer which has sought the deep pool for safety, and at other times have found the remains of

deer after they have been caught by their relentless pursuer, perhaps after several days of patient anticipation and lonely vigil. We have known of instances where unarmed men have tried to frighten one of them off and save the life of the fugitive deer but were unable to do so and were glad to get away unhurt themselves.

## Dangerously Injured by a Cow.

Little Ruth, the youngest daughter of Councilman and Mrs. C. C. Chappell, was terribly injured by a cow Friday afternoon, and the wound was of such a nature that it was decided to take her to Portland the following morning for treatment, where it is reported this morning, her condition is improving. The little girl with her elder sister went out to the corral in which the cow was kept, and where Mr. Chappell was working about her. Ruth wore a red jacket, which it is thought, had something to do with the animal's vicious actions, for as the little 5-year-old passed, the cow lowered her head, the tip of her horn catching the little girl in the corner of her mouth, and the side of her face, from mouth to ear, was laid open with a gaping, lacerated wound. Dr. Parson was immediately summoned, who took a number of stitches in closing the opening. It is expected that Ruth will recover, but her face will bear the marks of the cruel horn for many a day.—Ashland Tidings.
