A plan to give 10,000 a chance to see the Democratic national convention in session without discomfort to the delegates or material delay in the proceedings, has been evolved. The doors of the convention hall will be thrown open and the people will file through. A local committee favors the plan and it is thought that the national committee will do so. The Denver Press Club will entertain visiting newspaper men with free railroad passes to resorts in any part of the state.

The rumor that Secretary Loeb may be chosen chairman of the Republican national committee to manage the Taft campaign may be dismissed as foundationless. Had Loeb desired the place the announcement would have been officially made long before this. But he does not want the job for more reasons than one. If he took it the charge would be at once made that the President was "dictating the campaign" and Taft's candidacy might suffer some injury as a result. The President intends to keep his hands off the political helm this summer.

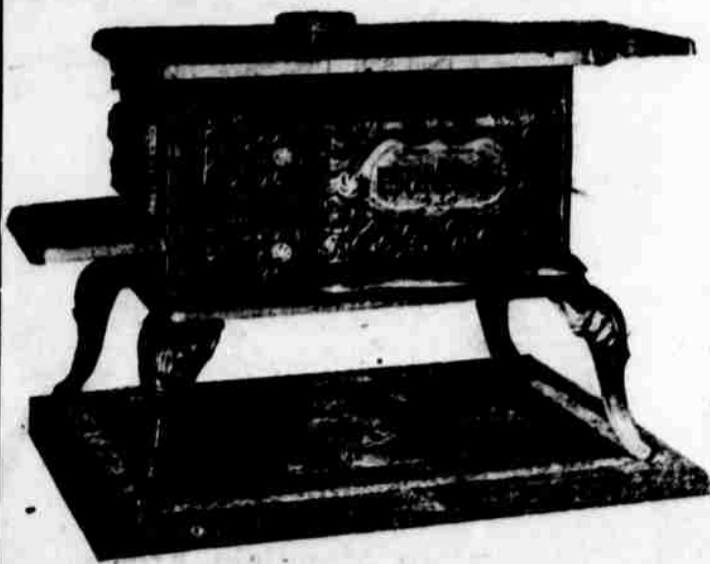
It is reported from Washington that plans are about completed for very thorough tests of field wireless telegraphy during the great military camps this summer. The tests will be extended through almost the entire time of the camp. Foreign experts and investigators are expected to be present, as information from abroad is to the effect that the American system so far as it has been developed has many advantages over the European.

An organization for the purpose of developing the farm lands of Oregon was favored at a recent meeting of the Portland Realty Board. The idea is to have a large tract of farming lands throughout the state cut up into smaller holdings for the benefit of newcomers inured to improved systems of cultivation.

Their object as stated is to have these large holdings divided among those who are content to adopt intensified farming methods in a few acres. The business could be managed in Portland as a central point, and the owners of the tracts permitted to share in the profits accruing from advanced values. Strangers might come to Portland and find out where the lands are available for cutting up and this part of the business could be rendered profitable for the real estate men engaged in it there.

RESTORATION OF ENTRY OF LANDS IN NATIONAL FOREST.
