

pany will manufacture and sell over 500 houses per year. But, say that it sold only 250, and at the average price of \$450 each, would be an annual business of \$112,500.00. Estimate that after paying all expenses, commissions for selling, adver-tising, etc., that the net profit was only 10 per cent on the selling price, the dividends on the stock would be 75 per cent on the investment. This is an extremely nominal estimate for Klamath Falls and vicinity. The Company has the whole State of Oregon in which to operate.

J. Fred Goeller, owner of "Klamath Falls Planing Mills," and one of the largest stockholders of this Company, has the manufacturing contract to make these houses, and will begin operations at once, with a force of workmen, and increase the number of hands as fast as the demands require it.
