

UPPER COUNTRY COMING TO FRONT

Prospects Good for Grain and Hay--The
Creamery Doing Business--Delegations
of Homeseekers Coming in July

(Special Correspondence.)

BONANZA, June 12.—Sunday afternoon the Bonanza baseball team earnestly endeavor to achieve victory over the Redmen's team of Klamath Falls at the county seat. The game between the two teams was held here Sunday before last, and ended in Bonanza's success by a score of 10 to 5. The Klamathites at a revenge, while the Bonanzas are determined to retain the lead and believe they are able to do so. Both teams will be strengthened and lovers of baseball will see a thrilling good game. On the 15th Bonanza also will play the Klamath Agency team at Klamath Falls. Twenty or more Bonanza people headed the stockholders meeting of the Klamath Water Users' Association and practically all supported the "conservative" ticket, which was decided, but the program outlined by a successful candidate for directorship is exactly in accord with our plan and the new board will be actively supported in the carrying out of its announced policies. The elimination of factional strife among the stockholders by the attitude assumed by the new board is a delightful and pleasant as it was unexpected. Prospects are most favorable for a grain and hay crop in this section, and good crops ensure prosperity.

The Bonanza creamery is doing a business and its product finds a ready market, for its butter is always the best that can be made. The Bonanza flour mill is equipped with the most expensive modern machinery, and the big wheat acreage and the assured large yield will make possible a long grinding season. Lake county buys largely from its mill.

Laborers en route for the Clear Lake dam pass through Bonanza and there is no doubt as to the completion of the dam this year.

Several men representing many of the Southern sections of California have visited our valleys recently and as a result of their very favorable opinion a number of large delegations of homeseekers will arrive in July. The quality of the soil and the low prices asked for land are available. One feature that appeals to all newcomers is the excellent drainage of all the valleys. Very few of the farmers wish to sell all their holdings, but many have more than they can clear and cultivate.

Land prices vary from \$12.50 to \$25 an acre. Bonanza expects to celebrate the Fourth of July and to furnish something and to furnish something for all visitors. So far as known, no other towns of the county will celebrate this year, and the town of the Four-Leaf Clover counts upon having a big crowd.

EVENTS OF THE COMING WEEK

Washington, D. C. June 12.—A total eclipse of the sun will occur Thursday, visible in nearly all parts of the United States and Canada. The eclipse is one of the penumbra type of solar eclipses which begins as a partial eclipse, becomes total and again becomes a partial eclipse. The central path of the eclipse lies wholly in the far north, and it will be visible only as a partial eclipse throughout the greater extent of North America.

The annual meeting of Flag day on Monday promises to be of a more general character than in the past. The day has been proclaimed a legal holiday by the governors of California, Oregon, Illinois, Wisconsin, Michigan and Connecticut. Argument in the appeal for Charles W. Moore from his conviction and sentence to fifteen years imprisonment is set for Monday morning in the United States Circuit Court of Appeals in New York.

The trials of a dock superintendent and six checkers of sugar weights, charged with conspiracy to defraud the United States government in the weighing of sugar at the docks of the American Sugar Refining Company in New York, are to begin Monday. The government claims to have been defrauded out of \$1,000,000 in customs duties by the manipulation of the scales used to weigh the sugar imports.

Wilbur and Orville Wright, the famous aeronauts, are to be honored by a two days' celebration given in their home town of Dayton, Ohio, Thursday and Friday are the days decided upon for the festivities. An attendance of notables from all parts of the country is promised for the occasion.

In Europe the event of the week will be the meeting between Emperor William and Emperor Nicholas, which is to take place in the waters of the Finnish Gulf. The German emperor will arrive on the imperial yacht Hohenzollern, while the Russian emperor will be aboard the Standard. Both

emperors will be accompanied by their foreign ministers, which is taken to indicate that important matters relating to international policies and possibly affecting the peace of Europe are to be discussed.

Republicans of Pennsylvania will meet in State convention at Harrisburg Wednesday to nominate candidates for State Treasurer, Attorney General and one Justice of the State Supreme Court.

Other conventions and gatherings of the week that will attract more or less attention will be the meeting of the International Council of Women in Toronto, the National Association of Credit Men in Philadelphia, the North American Wheat League, opening in Milwaukee Saturday, and the council of the alliance of the reformed churches throughout the world holding the Presbyterian system, which will begin its sessions Tuesday morning in New York City.

RAILROAD FROM RENO TO THE DALLES, OREGON.

RENO, Nev., June 11.—G. F. Dunaway, general manager of the Nevada-California-Oregon Railroad, this morning stated that the N. C. O. will within a few months begin the broad-gauging of its line from Reno to Alturas, a distance of 164 miles, and building an extension of this line from Alturas to The Dalles, on Columbia River, a distance of 226 miles further. This extension will also be broad-gauge.

Dunaway stated that \$5,000,000 will be expended on this new work of the N. C. O.

The extension and the broad gauge will enable the road to compete with other lines for the traffic of Northwestern California, Northwestern Nevada and the great expanse of territory embraced in Eastern and Central Oregon not now reached by any railroad.

At The Dalles connection will be made with the Oregon Railway and Navigation Company to Portland, and many points east, west and north. The road will bring a great traffic to Reno. It will open a vast territory capable of the greatest development and which will furnish a market for untold quantities of the products of manufacturing establishments.

PORTLAND PAPERS EASILY IMPOSED ON

Publish Numerous Interviews With the
Modoc Indians With Disparaging Comments Against H. G. Wilson

Some of the Modoc Indians on the Klamath reservation have again, as usual, taken advantage of the opportunity to secure a little notoriety and get their names in the paper. The recent trip of a half dozen of them to Portland at the expense of the government was a great occasion, and the amusing part of it is the fact that they were taken seriously by the Portland papers, especially the Oregonian. It is not altogether as amusing and harmless as it might be.

The light sentence of Barkley for the killing of Jacobs, and the apparent credence given to the arguments of the attorney for the defendant that Jacobs had no right on the reservation is bound to have a bad effect on the good behavior of the Indians. It can readily be seen what the result would be by encouraging the belief among a band of a thousand or more Indians that the fact of a man being on the reservation without authority, with the additional fact that he has a bad reputation, would justify, in a measure, his murder.

The Oregonian takes occasion to print many interviews with such Indians as Jeff Riddle, Tom Barkley and Hooper, which attack Superintendent Wilson, and follows this up with an editorial with assertions which its own news columns contradict. Editorially the Oregonian says that the Indian agent at Umatilla was removed as the result of a petition of the Indians, and intimates that such will probably be the result of the petition of the Indians on the Klamath reservation.

The writer of the editorial, if he knows anything, should know that his statement is a lie. The Oregonian previously published the reason of the transfer of McPartridge in its news columns. The agent at Umatilla was removed for not obeying an order of the department and the writing of a certain letter, and the petition of the Indians was not filed until after the order of transfer was made.

As to the petition for the removal of Wilson, it is simply the result of such encouragement as has just been given by the Portland papers to a certain disturbing element, which is always found in any band of Indians. The petition was signed mostly by Modocs, and a few of the more ignorant Klamaths, who were told that they were signing a protest against the return of the Modocs from Oklahoma. Superintendent Wilson, as are all of the Klamath Indians, was naturally opposed to bringing the Modocs back to this reservation and allowing them an extra allotment of lands. This naturally caused a feeling against him by the friends and relatives who remained here. The Klamath

Indians wanted to protest against the return of their former enemies, and pleaded with Wilson to go to Washington to represent them in the matter, but as Congress had already passed the act, they were shown that it would be useless. Another statement published by the Oregonian was to the effect that the Indians wished to attend the Rose Carnival at Portland with their brass band, and that Wilson refused to let them, when it is known that there is not a brass band on the reservation. The only thing of this nature is a few instruments which were left from a schoolboys' band which broke up years ago after the departure of Harry Monyer, who was their leader when he was conducting a store at the Agency.
