TO FIGHT DEMON RUM

tribution to the discredit of county prohibition and all other attempts to curb this traffic.

"The two recent automobile accidents in this vicinity causing two deaths, the result of carousals at suburban road houses where liquor is sold, have developed right here in Portland a strong sentiment which is in accord with our determination to put an end to the evil influence of the saloon and to prevent a recurrence of these tragedies. Until the Anti-Saloon league holds its annual meeting next month we will not work out the details of the vigorous campaign we propose to conduct. However, it will be an effective one. It may be decided to establish a daily paper in order more effectively to wage our fight."

Saloon or No Saloon.

The issue in this state next year will be plain—saloon or no saloon. It already has resolved itself into a decisive contest between the prohibitionists on one hand and the liquor interests on the other. Believing that state prohibition is not practicable and cannot be enforced, prominent workers in the local option camp are not lining up unanimously with the Anti-Saloon leaguers in their fight to reclaim the state from the saloon. While those allies of the anti-liquor movement probably will support the proposed constitutional amendment, they believe that strict regulation and high license should be tried first as a step preliminary to seeking state prohibition. The local optionists at the last municipal election submitted a

bill for an excise board for the regulation of saloons in this city, but the measure was defeated by an enormous vote. These forces are now waiting somewhat credulously to see what happens to the proposal for state prohibition, which, they recognize, is the next alternative.

In predicting success in their campaign for state prohibition the anti-saloon forces admit that they will not receive the support of a great many local optionists, who, while favoring regulation of saloons, do not believe in state-wide prohibition. The temperance advocates, however, say that any loss of strength on this account will be more than offset by the votes which will be gained from the saloon interests in some of the counties where local option is now enforced. Get-Even Votes Many.

At the office of Superintendent Knodell reports have been received from various of the dry counties of the state to the effect that there is a strong disposition on the part of many voters who favor saloons and frequent these resorts to vote for state-wide prohibition in a spirit of retaliation. In these counties this class of voters is known to feel more or less sore toward Multnomah county because of the fact that this is the only large county in the state in which the liquor business is not seriously curtailed through the operation of the local option law.

"If local option, which amounts practically to county prohibition, is good enough for us," argue this disgruntled element, "we will assist to vote the state dry and give Multnomah county, along with all other counties, a taste of what we have

been contending with."

Aside from being in the nature of a retaliation this probable action has another purpose. By carrying the state for prohibition they expect to demonstrate the inexpediency of this attempted reform, and, following a brief experiment, accomplish the repeal of the constitutional amendment providing for state prohibition and at the same time materially modify the provisions of the local option law, if an attempt should be made to reenact that statute.

In forecasting victory the prohibition workers are counting on their own strength, increased by the large majority of the local optionists and that proportion of the liquor vote in the dry counties which is being relied upon to vote for state prohibition merely to "get even" with other less arid sections of the state.—Portland Oregonian.
