**AN ECHO OF 27-10 CASE**

**Leslie Rogers Enjoined From Selling  
His Claim**

Deputy United States Marshal Griffith is in the city for the purpose of serving papers in a suit instituted by Frank Daniels against Frank Johnson et al. Leslie Rogers, assistant cashier of the Klamath County bank is one of the other defendants in the case, which involves land in 27-10.

Johnson, Rogers and two others succeeded in getting patents to their claim before the matter was hung up by the interior department, and it is to force them to re-convey this land to him that Mr. Daniels has begun suit. In addition to the papers in the suit, Mr. Rogers was served with an injunction, restraining him from selling or encumbering the property until the matter was settled, and setting November 2d as the date for his appearance in Portland to show cause why the order should not be made permanent and judgment taken in favor of Daniels.

Daniels claims that he has script on all of the land, but it would seem that in the case of Mr. Rogers he is mistaken, as the records in the Lakeview land office show that only forty acres of his claim is involved.
