NATRON CUTOFF TO GO TO COMPLETION

WHAT CALVIN SAYS

LEADING OFFICIAL OF SOUTHERN PACIFIC SAYS NEVER HAVE INTENDED ABANDONING SHORT CUT VIA THIS CITY

Vice President and General Manager E. E. Calvin of the Southern Pacific, who has just returned to Portland after inspecting lines in Oregon over which his jurisdiction will extend November 1st, says that the Natron-Klamath cutoff work is going on rapidly, and that active work will continue on the extension until the first of the year.

He expects to see the cutoff finished in a year and a half.

"We have never thought of ceasing construction," declares Mr. Calvin.

MEXICO CRISIS WORRIES INHABITANTS OF REPUBLIC

Three States Now in Control of Rebels, and One City Feels Insurrectionists Near By May Turn to Leaving

MEXICO CITY, Oct. 26.—The greatest crisis since Diaz withdrew is at Zapatlana, rebels being within four miles. Three states are already controlled by the rebels, and others are on the verge of rebelling.

Most of the federal regiments have gone to prevent the Guatemalan invasion. News is still awaited the battle of 500 federals and 2,000 rebels, started Tuesday night, which is still progressing. Rebels have cut the wires.

The rebellion is popular, and crowds are hailing Maderista officials. Madero and his cabinet claim that the revolution will be crushed within five days after his inauguration.

NEW SITE FOR DEPOT PICKED AT LAKEVIEW

Allegation Made That Selection of Location for N.C.O. Has Been Influenced by Street Fronts—Picking Up Desired Land

LAKEVIEW, Oct. 27.—General Manager Dunaway of the N.-C.-O. made a flying trip here last Sunday, and before he left selected another depot site, owing to the litigation necessary for securing the site formerly selected. The new site is at the foot of Center street, directly west of the court house, and about eight short blocks from the business district of town.

The committee having the selection of a site has had many difficulties in getting the land needed. It is claimed there have been silent forces at work getting options on every available piece of property as soon as it was mentioned as a possible site, and the price raised beyond reason.

The more progressive element among the residents of the county and town, who desire the railroad, and who have promised it the depot site and right of way, decried this alleged selfishness at a time when all should work for the common good.

Big Archie is a Plute, and well thought of among the white men of the county that have had business dealings with him. Many of these men were in the court room and congratulated him on the verdict. The evidence shown at the trial proved that Big Archie was tied when found in the morning shortly before the murdered mahala had been discovered.

Twenty Year Bonds Are Longest That May Be Issued By City Under Charter

Mayor F. T. Sanderson has called attention of the councilmen to the fact that the city may not, under the charter, issue bonds for a longer life than twenty years. At a meeting of the council a few nights since Councilman G. W. White urged upon the council the need of issuing bonds to take care of the floating debt of the city, and on his suggestion the council decided to call on City Attorney E. L. Elliott to draw up ordinances necessary toward an election for voting thirty year bonds to be redeemable after fifteen years. On Wednesday night, when the town dads got

together, his honor called attention to the fact that nothing longer than twenty year bonds could be issued under the charter, which contained on the part of the city's chief magistrate was upheld by Assistant City Attorney W. H. Shaw on inspecting the charter.
