STRAUSS GIVES IDEA OF RUSSIA'S TREATY ACTS

Government Not Wieldy in Defense of Jews, He Says as Proponent of Legislation and Catholic Priests are Harassed as Well

NEW YORK, Dec. 21.—Commenting on the action of President Taft in denouncing the Russian treaty of 1872, **U.S. Senator Charles McNary**, secretary of the Senate, and one time ambassador to Turkey and on Saturday, on International law, issued the following statement to the United Press:

"It must be understood first of all that this movement is not made wholly in defense of the Jews. Catholic priests, Protestant clergymen and missionaries are discriminated against. Here is the situation in a nut shell: In 1872 a Treaty between the United States and Russia was signed. It was an agreement whereby the citizens of each nation had free access to all parts of the other. No exceptions were stipulated. But about forty years ago Russia began discriminating against Catholic priests, Protestant clergymen and Jews.

"When an American appears on a Russian frontier prepared to enter by must have his passport vised by the Russian consul. A number of questions are asked, including what are his profession and religion. If he travels replies that he is a priest, a clergyman, or missionary or a Jew he is barred. That is a violation of the treaty."

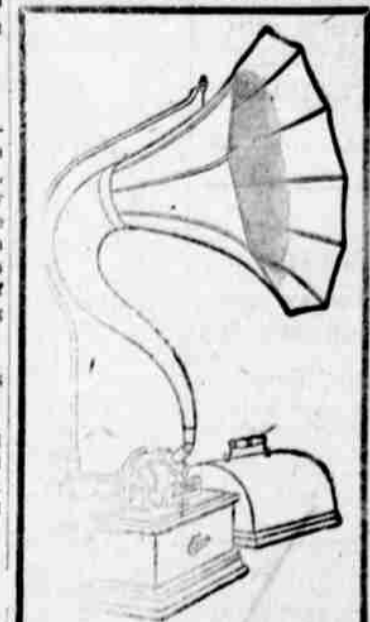
