FOREST FIRES DO NO DAMAGE

THREE OUTBREAKS REPORTED TO THE DISTRICT FORESTER FROM THE CRATER NATIONAL PARK IN THIS COUNTY

The district forester's office in Portland has received notice of three forest fires started in the Crater Lake National Park within the past week.

The starting of at least one of these fires was witnessed by guests of the Crater Lake Hotel company last week. Lightning was the cause. A bolt struck a huge tree on the north side of the lake, and set fire to the tree. Although rangers were dispatched to the scene at once, the fire died out of its own accord.

No damage to speak of was done by the other two fires, which had their origin in the same manner as the one witnessed by the tourists.

The dry weather of the past few days has made the conditions more favorable for fires in the forests, and the watch is being redoubled on all of the reserves.

WILL PROBE ACCIDENT TO BIG BRITISH SHIP

LONDON, July 24.—A court of inquiry has been appointed to investigate an accident that might have resulted in the destruction of England's newest dreadnought, the Thunderer, at the Devonport dockyard recently, the facts concerning which have just become known.

The Thunderer was taking on her first supply of ammunition, consisting chiefly of 5-foot lyddite shells. One of these, fully primed, slipped from its sling just as the crane was swinging it over the magazine hold. The shell plunged through the three-foot hatchway, but luckily its fall was broken by striking a ladder, down which it slid harmlessly.

As the magazine was nearly full of similar projectiles, if it had exploded experts say that not only would the ship and all on board have been annihilated, but probably a large portion of the dockyard would have been blown to pieces.

LETTERS FROM THE PEOPLE

Editor Evening Herald:

An article under the caption "Brower Collapses," as published in your issue of the 27th of April, having come to my attention, I notice several expressions accredited to Mr. Murdoch relative to my condition on that morning of the day on which I should have tried as his attorney the court house case, which are somewhat misleading, and among them one to the effect that when he came to me in the morning I "seemed to be wholly oblivious to the case, and not to know anything about it."

I beg to say through your columns that such statement accredited to Mr. Murdoch has little or no foundation in fact; and I may say further that Mr. Murdoch disavows having made such statement, and also, as well, any one of several others accredited to him in such connection, of similar import.

It is true that I had become prostrated, or "collapsed," if one prefers that word, and did not have full control of my motor nerves, and there was sufficient reason for such condition. But when Mr. Murdoch asked me if I would be able to go on with the case, I told him I thought I would be all right in a little while—I asked him to let Mr. Elliott, who was in my office at the time, help me—I carefully gathered up the papers of the case which were scattered over my desk, and classified them and put them into proper envelopes—I dictated to Mr. Elliott for typewriting certain matter in the case—I asked Dr. Wright, who had come at my call by telephone, if I would be able to go on with the case, and he said he thought I would not, and that it would be best for me "to go home and take a good rest—take a good sleep." Now, if I was oblivious to the case, and knew nothing of it, how should I do all these things about it.

It is true that I did not discuss the merits of the case at the time, and there was not any occasion to do so.

People seem to think that I broke down simply because of work on the court house case. Well, in one sense, I did, but in another sense I did not, for it was not that alone. Through the court house case in one way and another, I was many months behind in my work, including several cases in the circuit and justice courts of this county, some cases in the supreme court and a case in the United States court at Portland, in the last of which I was bound to have an answer filed by the first Monday in May, only a few days ahead. This federal court case was a very complicated matter, and required very careful preparation.

I had slept on an average less than six hours a day for more than three months, and much of the time less than three hours a day.

During the four days prior to the 27th, I had been required to attend as a witness in land case for two half days, and two other half days were spoiled by attendance for the same purpose, though not actually on the witness stand, and I was thus as well as in other ways prevented from completing the arrangement of the final details of the court house case; and on the night previous, the 26th, I was



further prevented from completing such details in typewriting, by being talked with, as was suggested by my client, till about 11 o'clock.

My sleep that night amounted to less than two hours, and I went early to my office, and began typewriting at ten minutes before six. At half past six I found that I had written less than one line, and realized that I had been unconscious for probably half an hour or so. I at once called Dr. Wright by telephone, who came somewhat later, and after a short time I had him telephone for Mr. Elliott, who came at once.

I had the entire case prepared and blocked out in pencil as regards the evidence to introduce and the law authorities on the various points likely to arise, excepting a few points from one of the county officers, and need only to get it into a little better arrangement in typewriting.

I was thoroughly exhausted, but knew pretty well that there was a court house case on, and was well aware of the details of it at the time.

Through this circumstance the active conduct of the case went to other hands.

I have been asked many times what I thought of the circuit court's decision in the case, and I have had but very little to say, for the reason that I do not consider it in good taste for an attorney to say much about decisions in cases with which he has been connected. But I will say in this connection that I am well aware that the laws of Oregon in relation to where the county officers shall hold their offices and where the courts are to be held, as well as the majority of all our other laws excepting those regulating such matters as the catching of trout and shooting of jack-snipe, are ridiculously indefinite and uncertain; and, if it is true, as was indicated in the court house decision that there can be a county seat without any boundaries, and the county officers can have their offices any old place in the county, one here another there, scattered all around anywhere, it is in my judgment fully time for new arrangements to be made.

PORTLAND TRIES FIRST

CO-OPERATIVE GROCERY

PORTLAND, July 24.—As the result of investigations of the "high cost of living," made by a committee appointed by Mayor Rushlight several months ago, the first co-operative grocery store in Portland is in full operation.

The store was furnished and stocked as a cost of \$2,000, realized through the sale, at \$10 each, of membership in the First Mutual Association, the official name of the concern. Benefits to the 200 members of the association will not accrue through the sale of groceries at less than the prevailing market prices, but through the division of profits at the end of each three months, in proportion to the value of the purchases made by the members during that period. Any person may make purchases at the co-operative store, but members only are permitted to share in the profits.

R. L. Voelker, manager of the store, stated that, as a conservative estimate, from \$5 to \$6 a month should be saved to families of average size holding membership.
