## ENGINEER ASKS A SALARY CUT

DON J. ZUMWALT REQUESTS THE  
COUNCIL TO CHANGE HIS RE-  
MUNERATION FROM AMERICAN  
TO EUROPEAN PLAN

Because the winter work does not  
promise to be active, City Engineer  
Don J. Zumwalt last night suggested  
to the city council that his monthly  
salary be discontinued, and that he  
be paid at the rate of \$10 per day  
for such work as he is called upon to  
do for the city. The plan met the ap-  
proval of the council, and it was so  
ordered.

The petition of James H. Driscoll  
for a renewal of the liquor license at  
the White Pelican hotel was granted.  
W. P. Johnson and Joe McDonald  
signed as sureties.

Herbert S. Crane, the attorney, ad-  
dressed the council concerning the  
poor lighting service on Sixth street  
in the hill district. The matter was  
referred to the light committee.

A deadlock occurred when the mat-  
ter of buying a team came up. It was  
in the shape of an ordinance, and was  
taken up last night for its final pas-  
sage. Four councilmen favored the  
ordinance, while four others were op-  
posed to it.

## TAFT LEADERS IN PORTLAND CERTAIN

PORTLAND, Oct. 8.—Many en-  
couraging reports reach headquarters  
to the effect that the working men of  
Oregon are going to vote for a con-  
tinuance of prosperity and jobs for  
father, new dresses for mother, and  
moving picture shows for the kiddies,  
and against another soup-house chap-  
ter of horrors like that which occur-  
red all over the country under the  
Cleveland administration in 1893.  
Working men in the neighborhood of  
Portland who two weeks ago were talk-  
ing some about Wilson, now openly  
declare that they do not intend to  
"take a leap in the dark" over the  
free trade precipice.

Some of the counties which were in  
the "Bull Moose" class a few weeks  
since, have undergone a great change  
lately for the "let-well-enough-alone"  
idea is spreading to every part of the  
state. A leading republican politi-  
cian reports to headquarters now that  
"there is a constant drift towards the  
president, and he is gaining every  
day, and I look for him to have a  
substantial majority." A Taft Club  
will be organized in Tillamook on  
October 12th.

Grant county is another example  
of the remarkable change of senti-  
ment which has taken place in the  
state. Good political guessers in that

county predict that Taft will surely  
carry it.

Klamath is another county which  
will undoubtedly be in the Taft col-  
umn in November. Voters from that  
county report that their fellow citi-  
zens are doing some tall thinking,  
and have come to the conclusion that  
it is better to vote for more republi-  
can prosperity than to take a chance  
on new principles and new men.

Thousands of red and white Taft  
buttons have been sent out and given  
away at headquarters during the past  
week in response to requests. Men  
who were talking Roosevelt a short  
time ago are now wearing Taft but-  
tons, according to numerous callers  
at headquarters. One man in South-  
ern Oregon writes: "You sent me  
twenty buttons, and they were gone  
in as many minutes, and men offering  
to buy more at any price. Send me  
300."

Another republican in Eastern Ore-  
gon said: "I have had to fight to  
keep the button you sent me; I could  
use 100 in half a day."

Taft's buttons can be seen every-  
where on the streets of Portland, in  
hotel lobbies, etc., etc., where they  
were few and far between before the  
visit of Roosevelt. The feeling that  
Taft will carry this state has now tak-  
en firm root and is growing rapidly  
every day.

## SHAKEUP COMING IN EXPRESS RATES

SALEM, Oct. 8.—On its own mo-  
tion the state railroad commission  
started the ball rolling for a read-  
justment of all the express rates in  
Oregon. Notice that a hearing will  
be held here Thursday, November 7,  
was sent to the Wells Fargo Express  
company, the American Express com-  
pany, the Northern Express company  
and the Great Northern Express com-  
pany.

This notice states that the com-  
mission has been investigating ex-  
press rates, and finds cause for a  
hearing to determine whether any of  
the rates are unreasonable and un-  
just.

"This hearing is particularly made  
necessary by the general readjust-  
ment of express rates that must fol-  
low the recent order of the interstate  
commerce commission, outlining a  
new system of handling the express

and uses it in improving his land, and

So it is with most articles of per-  
sonal property. The bill proposes to  
tax franchises: Water, light, etc.  
Someone will say at once that the  
companies will charge the consumer  
exorbitant rates under the specious  
plea of "taxes to pay." The public  
can regulate franchise prices. Many  
years ago, in Munn vs. State of Illi-  
nois, a case well known to all law-  
yers, the court ruled that when pri-  
vate property is devoted to public use  
it shall be subject to public control.  
This has been the basis of public con-  
trol of public franchise prices. If  
corporations holding such franchises  
dislike regulation in the interest of  
the public, let them sell their facili-  
ties to the public, in whom the own-  
ership should be. Voters in Oregon  
are in a position to do as they please,  
and that speedily. If the graduated  
single tax amendment is adopted, and  
any county doesn't like it, it can re-  
turn to the present system at the next  
election. If the proposed bill offers  
relief from unjust burdens and prom-  
ises a more equitable method of taxa-  
tion, why not give it a trial? The  
same danger signals were unfurled  
when the initiative and referendum  
were proposed, yet we do not observe  
any indications on the part of the  
mass of our citizens to return to the  
former corrupt system. The writer is  
of the humble opinion that when the  
voters get and take time to investi-  
gate the merits of the graduated sin-  
gle tax measure they will favor it.

B. Atchison, chairman of the state  
railroad commission. "We want to  
get a firm grip on the situation and  
line Oregon rates up so there will be  
no injustice to any community, and so  
every community and every industry  
will get the full benefit of the changes  
being made in our express systems."

The order of the interstate com-  
merce commission fixes three classes  
of rates, general, special and food-  
stuffs, and divides the entire country  
into small districts, and makes the  
rates from all points to all points in  
another district the same on each  
classification. A hearing on the com-  
mission's order is to be held at Wash-  
ington, D. C., tomorrow.

That the re-adjustment will re-  
sult in the lowering of many of the  
express rates is the expectation of the  
state railroad commission.
