When the horse car was driven out
of almost every other American city
by the trolleys, in most cases many
ears ago, it took its last stand in New
York, and it has lived on East
Broadway, one of the most thickly
populated streets in the world, has
never had any other transportation
than horse cars.

Two New Yorkers were hurrying
along the streets while they boasted
about the enormous skyscrapers.

rived from a small town in Illinois.

The New Yorkers overheard and
stopped boasting. The boy had lived
to be 12 years old without ever hav-
ing seen a horse car. They were abo-
lished in his part of the United States
before he was born. Now, however,
the legislature has passed an act
which requires the street railway com-
pany in control of the local lines to
take off the horse, and substitute trol-
ley cars. When this is accomplished
there will be few horse cars left in
the United States.

Kohlemainen, Great Runner



WILHE Kohlemainen, the second
brother of the famous family of Fin-
nish distance runners, only recently
attested his right to be called the
greatest professional distance runner
in the world by beating a field of nine
of the finest runners in America in the
16-mile championship race of the Mon-
ument club held in New York
York on May 4.

Kohlemainen, like his brother Han-
nes, who won the principal honors at
the Olympic games at Stockholm last
summer, is a running machine,
though by long odds not as pretty a
runner as the younger Kohlemainen.
Wilhe goes into every race facing the
prospect of losing a whole spongeful
of blood. His early exertions in run-
ning a distance always start his nose
bleeding, and often the blood drips as
he continues to run. In his
recent championship performance in
New York, Kohlemainen's nose bled
from the time he passed two miles un-
til he had run eight.

EXPLOSIVES TO BE RULED OUT

COMPLAINT AGAINST DYNAMITE CACHE IN CITY WILL RESULT IN ORDINANCE CONCERNING EXPLOSIVES

One of the next ordinances to be considered by the city council will be one limiting the amount of dynamite, gunpowder, gasoline and other explosives that can be kept in the city limits by any firm or individual, and compelling the storing of larger supplies out of the city limits.

This matter came up through a complaint against the Baldwin Hardware company's powder storehouse on West Main street. The complainant stated that, in addition to the danger to life, the insurance company threatened to cancel his policy.

City Attorney Rutledge was instructed to draw up an ordinance covering not only dynamite, but other forms of explosives, including gasoline.

OREGON CITY LAWYER BRINGS OUT SALIENT FACT IN CONNECTION WITH CONSTITUTIONAL AMENDMENT

OREGON CITY, Or., May 13.—Attorney J. F. Hodges of Oregon City has discovered what he declares is a flaw in the recall amendment to the state constitution.

The amendment reads: "There may be required 25 per cent, but no more, of the number of electors to file their petition demanding a recall by the people."

Attorney Hodges says: "There is in the foregoing phrase nothing but a provision that 'there may be required.' Necessarily the requirement must be by law—either that of the legislative assembly or that of the people. No such legislation has been had.

"There is another provision that makes legislation necessary. This says: 'Such additional legislation as may aid the operation of this section must be provided by the legislative assembly.' There has been no such legislation."
