alshed by Ferris, and awaited the
time to leave.

According to the girl's testimony,
the carpenter told her that it would
be best to wait until school was in
session. She says she intended to
leave here on the train, but that Fer-
ris told her it would be best to go to
Dorris in a conveyance and take the
train from there.

The two planned for some time, the
girl told the court, until the night of
September 24th, when Ferris met the
girl, told her they would leave the
following morning, and took her suit
case, after designating a place of
meeting on the West Side.

On the way to Dorris, she said, the
two discussed what name she should
assume, and they agreed on "Aurora
French." Ferris told her that a young
girl was under in a small town than in
a large city, and they agreed upon
Oreling, Calif.

The girl stated at Dorris, changed
her school clothes she had worn when
she left home ostensibly to go to
school, to the womanly attire pur-
chased, and took the train from Dor-
ris to Oreling.

The train attracted considerable at-
tention at the time, and Ferris, short-
ly after his return to Klamath Falls,
was arrested. He admitted that he
had aided the girl in leaving town,
and told where she could be found.

The defense, which is being con-
ducted by William H. Shaw and Hor-
ace M. Manning, maintains that the
girl repeatedly told Ferris that she
was mistreated at home; that her
mother had wished she was dead;
that she did not believe that Mrs.
Ida Fink was her true mother, and
had made similar complaints, asking
the aid of Ferris. The defense holds
that the girl asked financial assist-
ance from Ferris, and that he gave it
with the understanding that he would
be reimbursed after the girl went to
work.

That Ferris was not the only man
whom the girl told of her alleged mis-

treatment and asked assistance of,
was the statement made by Attorney
Manning in his opening argument to
the jury. He said he would produce
witnesses to prove this.

THE FOLSOM TIGER IS REPRIVED

outcome of Oppenheimer's last legal
battle for his life, an appeal to the
Supreme court of the United States.

Oppenheimer, the "Tiger of Folsom
Prison," and the most famous convict
in the West, has made a remarkable
fight for life that may lead to the
United States supreme court. Oppen-
heimer was sentenced to die under a
California law which makes an attack
on a prison guard a crime punishable
by death.

Oppenheimer was sentenced from
Oakland to a fifty-year term in Fol-
som prison for robbery in August,
1885. A few years later he fatally
stabbed a fellow prisoner named Ross.

He was convicted of the murder
and sentenced to life imprisonment in
San Quentin. There he stabbed Guard
McDonald, but not fatally.

Placed in solitary confinement, he
mysteriously secured a piece of steel,
made a file and saved his way to lib-
erty.

Oppenheimer was captured, tried
for his attack on McDonald, sentenced
to death and sent to Folsom prison.
While awaiting execution, "Tiger"
Oppenheimer stabbed Convict Guilford
to death with a fork, following a
trivial argument while eating.

Once again Oppenheimer was
placed in "solitary," and once again
he secured a piece of steel, made a
saw and got out into the corridor,
where he was captured. Oppenheimer,
it is said, has a dozen or more time
secured pieces of metal and used
them to saw his way from his cell,
but the authorities have sup-
pressed the reports of it.

His almost superhuman ability to
secure material for saws and weapons
made him the equal of the notorious
Jesse Pomeroy, confined for nearly
fourty years in Charlestown, Mass.,
penitentiary in this respect.
