SAXTON DECLARES HE IS INNOCENT

me back the second time to Weber. I got to jail that time about 4 o'clock p. m. At 3 o'clock the next morning Mr. Spangler awoke me, and all alone he took me through a long dark corridor without any kind of iron on me. The train going to Portland was late, and about 5 o'clock a. m. Mr. Spangler did take me into the train and did then and there deliver me up to the care of Mr. Fred Morley. Mr. Morley did then and there place two iron bands around my ankles and bring me to Klamath Falls.

"After I arrived in this jail I wrote a letter to Mr. J. W. Siemens, the banker. I told the gentleman I was indeed very sorry to know that some rascal has got me mixed up in this tangled mystery. I told Mr. Siemens the same words I now tell you: 'I am absolutely not guilty.'"

"I am absolutely innocent, and I was 700 miles away from Tule Lake at the time this forgery was alleged to have been committed in February 6, 1913.

"Your papers give me the credit of being a married man, and have said I and my wife did live for a time near Tule Lake. I here tell you I was born July 25, 1889. I am 44 years of age, and never in my life time have I been a married man. Never in my life time have I ever traveled over one day with any woman as my wife.

"God knows I am stoned against. Should I lay on my dying bed this very minute, I would still say to all men on earth, and to God and the Angels of heaven, I am dying absolutely an innocent man.

"I am a rover on account of ill health, and have seen much of our beautiful country, and in all of my wanderings I have lived an honest life. I have traveled on foot in June, this year, by Tule Lake, and stopped only one night in each farm house. I am a small 110-pound barber, and an expert horseman. I will be remembered only as the little barber at the lake, and right here let me tell you. I never did live at Tule Lake in my life only as I traveled through, working on the road as a barber. Dear readers, do not condemn this lonely wanderer until you have learned more of the facts.

"There is hope in you hill tops. And love in you light. I let hate and despondency Die with the night.

"I am all alone in a strange city, but I know that the good readers of this paper will see to it that Eugene Saxton shall have a fair, square, honest trial. That, my friends, is all I ask of you. Please do not condemn me until you know the facts of the case. I have nothing to hide from you. I want to see the guilty party caught.

"I do not believe that Mr. Siemens or anyone of the Bankers' Association would care to see an innocent man railroaded anywhere. I say once again I am:

"Absolutely Not Guilty!"

His Aeroplane Beats a Train



C. Murvin Wood, the aviator, proved that he could fly from New York to Baltimore in faster than one of the regular trains. He meant to beat the train to Washington, but lost his way outside Baltimore, and later his engine stopped, and he found it necessary to alight. The distance was about 225 miles.

He left Hempstead, L. I., where the Moisant aviators, of whom he is one, have their headquarters, and caught and passed a train which left Jersey City on the way to the capital. Wood said:

"I started out fine. The motor hummed along at 1,000 revolutions a minute, and I must have covered at least eighty miles the first hour. Then I had trouble with the motor all along and had to keep at a very high altitude in case she should get stalled on me. That is why you all lost sight of me.

"Most of the time I flew above the clouds and my vision was hardly more than five miles radius on account of the fog. The highest altitude registered is 7,350 feet, which I reached at Havre de Grace. Finally near Galtsburg my engine stalled, and I had to volplane to the ground."

During the past half century you have seen the school house take the place of the military post on your reservations. The administration of Indian affairs has been taken from the military to the civil arm of the government.

The education and industrial training the government has given you have enabled thousands of Indian men and women to take their places in civilization alongside of their white neighbors. Thousands are living in substantial farm houses on their own separate allotments of land. Hundreds of others have won places of prominence in the profession, and some have worked their way into the halls of congress, and into places of responsibility in our state and national governments. Thirty thousand Indian children are enrolled in the government, state and mission schools.

The Great White Father now calls you his "brothers," not his "children." Because you have shown in your education and in your settled ways of life, staunch, worthy, manly qualities of sound character, the nation is about to give you distinguished recognition through the erection of a monument in honor of the Indian people in the harbor of New York. The erection of that monument will usher in the day which Thomas Jefferson said he would rejoice to see, "when the red men become truly one people with us, enjoying all the rights and privileges we do, and living in peace and plenty." I rejoice to foresee the day.

It gives me pleasure as president of the United States to send this greeting to you, and to commend to you the lessons in industry, patriotism and devotion to our country, which participation in this ceremony brings to you.

Two Democratic Senators Fight



WASHINGTON, D. C., Aug. 14.—

Senators Gilbert M. Hitchcock of Nebraska and James A. O'Gorman of New York, both strong democrats, and the latter an especially strong adherent of the Wilson administration, have begun a fight on the Owen-Glass currency bill, which President Wilson has said time and again he wishes passed at the extra session.

Senator Owen reported to the president that forty-two out of fifty-one democrats are on record in his poll as favoring the bill; two, Senators Bankhead of Alabama and Clarke of Arkansas, are undecided about proceeding with the currency question at this time; five others have stated they hoped the question could go over to the next session on physical grounds, and only Senators Hitchcock and O'Gorman are said to have stated their unqualified opposition to legislation at this session. Nine republicans are said to favor legislation at once.
