Lord Chief Justice Dineen, who was twenty-fourth Governor as lord chief justice of England in a young man, was appointed to his high judicial position. He was born in 1849, and is therefore 64 years of age. He began life on the London Stock Exchange, and later studied law. FAIR BUILDINGS READY ON TIME

Army of Laborers Making Progress

Novel Ornamental Stone Used on Machinery Hall

(Herald Special Service.) THE EXHIBITION Nov. 17.—An army of laborers is working in teams on the fair buildings, and in view of the fact that the exhibition will be opened in a few days, it is stated that the buildings will be completed several months in advance of the opening of the great fair. One of the most interesting pieces of construction work now going on is in Machinery Hall. The large structure is crossed each way by a series of lofty gables, 126 feet high, while the height of the building from the floor to the roof is 135 feet. The ornamentation is being placed on the exterior of Machinery Hall. It consists in a cement composition called imitation Travertine stone. It is a faint ivory yellow in color, several shades removed from white, and at a distance presents the appearance of white. In the brilliant sunlight this shade will not be as glaring upon the eyes as would pure white. Fleets of steamers are unloading lumber at the exposition docks. More than 40,000,000 feet of lumber have been delivered of the required amount of 70,000,000 feet. As many as nine steamers discharge cargoes at one time.

WASHINGTON, D. C., Nov. 17.—For more than twenty years, ever since he was a reporter on the Evening Telegram of Portland, Ore., John Barrett, now chief of the Bureau of American Republics, has refused to marry. In that time he has been United States minister to Siam, to Panama, and to some other South American republics. He has been fairly well fixed in this world's goods, and for several years he has been in Washington and Washington society as head of the Bureau of American Republics. John has had many chances to marry—for lots of people think he is handsome. Yet he is not married at the age of 46. Now, however, the rumor is rife in Washington—society guesses it is much more than a rumor—that he is to wed Mrs. Thomas F. Walsh, widow of Colorado's mining king, who isn't worth a cent less than \$40,000,000. In addition she is the grandmother of the famous \$100,000,000 baby—the McLean baby. When the son of the house of McLean, he of the Cincinnati Enquirer, and the daughter of the house of Walsh wedded, it was a mingling of the most millions Washington knew. Then came the baby, the best advertised baby in the United States. Mr. Barrett will thus come to distinction, should he wed Mrs. Walsh, of being the step-grandfather of a \$100,000,000 baby. Mrs. Walsh is one of the society leaders of Washington. Her home is one of the finest in the city. She is able to spend more money on entertainment than any other woman in the national capital. If John Barrett sits at the head of the table he will, his friends declare, become one of the most lavish entertainers in the whole of American history. John's single ambition since he was a boy has been the presidency of the United States.

Mrs. Wakefield to Be Hanged Soon



Mrs. Nellie Wakefield, 24 years old, one of sixteen children, who insisted she was not properly reared because of the large family her father had to care for, is under sentence of death in New Haven, Conn., for killing her husband last June. He was considerably older than she. She says he treated her cruelly. Then James Plew came along. He clothed her children and treated her kindly. After a while she began to think more of him than her husband. Then they took him out in the woods and killed him. Two weeks later, drawn back to the scene, in accord with the tradition about murderers, they were traced and caught. Plew confessed. Mrs. Wakefield pleaded not guilty and was convicted. Governor Baldwin is receiving many letters asking him to pardon her, but he has so far answered that he has power only as one of the board of pardons, which has not yet begun to consider her case. you and each of you are hereby summoned to appear and answer the complaint filed in the above entitled suit within six weeks after the first publication of this summons; and you will take notice that if you fail to appear and answer or plead within the said time, the plaintiff for want thereof will apply to the above entitled court for the relief demanded in his complaint filed herein, to wit: For a judgment, order and decree against Oscar C.
