OUR WEEKLY SERMON

"The Sons of God"

By R. J. S. Stubbled, Pastor First Presbyterian Church

"The earnest expectation of the
creature waiteth for the manifesta-
tion of the sons of God."—Romans,
8:19.

The subject of our text is creature.
In this chapter the apostle deals with
the creature's expectations and disap-
pointments. Paul speaks out of his
own experience and from his own ob-
servations. He assumes that every
creature has similar experiences and
expectations. Everywhere he finds
men expecting that which he has ex-
pected, so he generalizes and says
"The earnest expectation of the crea-
ture waiteth for the manifestation of
the sons of God." He had been speak-
ing of Christ, the Son of God, and
when he here speaks of "the sons of
God," some of our best scholars say
that he means children of God who
are like Christ.

Men have always expected a man-
ifestation of the sons of God. This ex-
pectation has no doubt grown very
largely out of sheer need. We have
learned that God provides for his
creatures all things they really need,
and when we discover a great need in
the soul we naturally conclude that
God has provided something to meet
that need.

All through the ages men have felt
the need of some manifestation of the
sons of God. The old Greeks and
Romans, when they were in a semi-
savage state, earnestly expected a
manifestation of the sons of God. In
the hour of defeat and failure the
soul of man naturally longs for divine
fellowship. When we are disappointed
and the soul is full of sorrow we
naturally turn our faces toward
heaven, and long for divine fellow-

whole being relieved by vivid color

must feel, especially as they no doubt

The greatest joys of the new furnis-

empty wall, its carved frame repeat-
ing the same basket decoration in
rich colorings.

In the kitchen is where the modern-
ist really shines, however, with each
pepper pot and dish towel decorated
with an appropriate motif that is car-
ried throughout the sacred precincts
of culinary art.

It certainly is going some when
even the gayly colored quill pen on
your desk or the cord on your desk
telephone may throw your whole liv-
ing room furnishings out of harmony.
No wanted the bride wears a worried
look until her furnishing is finished.
The wonderfully charming effect of
the completed product, however,
