

Multnomah "Economy" Turns Into Big Joke

(Herald Special Service)

SALEM, Jan. 19.—It appears that there are two kinds of economy advocated by members of the legislature this session, and particularly among those who are here from the state's metropolis.

There is one economy which is loudly advocated on the floor of the House before the galleries and the representatives of the state press. Then there is another economy that is put into practice in the secrecy of the committee rooms.

Many members of the Multnomah contingent have made glowing speeches in public advocating the depriving of the members of the necessary stenographic help at their desks, knowing that what they might lose in that way could be more than made up by assigning all their friends to committee clerkships and appointments. This is the practice that is now in vogue, and nearly every important committee controlled by Portland members, has been packed with special appointments, many of whose service are entirely unnecessary.

The members from the outlying

districts in the state have consistently shown a disposition for practical economy, and have insisted on sufficient competent help to enable them to properly handle the mass of bills that will come before them for consideration in a proper and business like manner. They claim that they came here to work and are anxious to get down to real business.

Almost as a unit the members outside of Multnomah county strongly advocate and voted against adjournment from Friday until Monday. Although they carried their point and prevented the whole legislature from taking a vacation in the middle of the week, with the exception of two, the Portland delegation were excused from attendance and were absent from their work.

Many of the outside members spent Friday, Saturday and Sunday working on the bills on their desks and visiting the various state institutions which are asking for appropriations. From present indications if there is real economy secured for the people at this session it will come through the country members, as the "twelve apostles" from Portland are beginning to become a joke from a business standpoint.

Belgians Cannot Come Over Here Just Now

LINCOLN, Jan. 19.—Belgium can now co-operate with organizations of Nebraska or with citizens of other states to organize a movement to place on farms in this country desirable immigrants from that stricken land. A letter from Minister Havens of Belgium to Secretary Whitten, of the Lincoln Commercial club, conveys this information.

The letter came in reply to one sent by Secretary Whitten to Secretary of State Bryan, which Mr. Bryan turned over to the Belgian minister.

In his communication, Mr. Whitten emphasized the desirability of making an organized effort to choose the best of the Belgian farmer class, who are expected to leave Europe as soon as they can, and place them on farms in the middle west.

The Belgian minister expressed his gratification at the interest taken in his people by the people of Nebraska, but he says that under the present conditions it would be impossible to take up any such plan just now, but that he would be glad to co-operate in such a movement later.

Hobey Baker, Greatest Hockey Player



Canadian hockey players and experts declare that Hobey Baker, the former Princeton University athlete, who is now a member of the St. Nicholas skating club team in the American Amateur Hockey League, is the greatest hockey player that ever cleft the ice with a steel blade. The men from the north make no exception in expressing this remarkable opinion. It goes for them all, amateur and professional.

Baker has already beaten, single handed, two of the fastest amateur teams in Canada this winter. On December 28, against Toronto University, the former Tiger star, playing at rover on the St. Nicholas seven, secured five goals unassisted and carried the puck up the ice for the other two successful attacks against the Toronto goal. The score was seven to six in favor of St. Nicholas. On January 2, playing against the Montreal Victorias, Baker gave the most wonderful exhibition of hockey playing ever seen in the United States. With practically the whole Canadian team united in their endeavor to put him out of the game, Baker electrified the crowd by skating rings around the fast Canadians—fairly standing them on their heads. He was finally cut with a skate and had to retire before the final whistle.

Baker weighs 170 pounds, and yet is as fast as a featherweight. Phil Kearney, former champion speed skater of America, has declared that in his palmest days he could not have matched the speed that Baker is showing in every one of the hockey matches that he plays in. A very famous Yale athlete once said of Baker: "In football togs he's a marvel at dodging, but on skates he's uncanny." In one of the melees in the St. Nicholas-Victoria hockey game five of the fast Canadians were lying on the ice at once as a result of their attempts to stop the dodging, twisting, Princeton star.

Baker would have made a wonderful track athlete had he gone into that branch of sport. The fact is, he was planning to begin practice at throwing the javelin, with the 1916 Olympic games in view, when the European war broke out last summer. Hobey is also an enthusiastic motorcyclist. He was right in the midst of a tour of the Continent last summer when the war storm broke. Baker found himself in a pretty tight place, but he wriggled through the gathering hosts of war in the same brilliant manner that he slips through the opposing team's defense on the ice.
