This is a photograph of St. Patrick's Cathedral, the greatest and most costly church edifice in the United States, which a band of anarchists tried to blow up during early mass Tuesday morning, March 2. The photographs of Frank Aberno, an anarchist, 24 years old, and Charles Carbone, another, only 18 years old, are also shown.

The motive for the attack on the church is not known, other than the fact that the Catholic church has always been a bitter opponent of anarchists here and abroad. Arant Going to Court

Former Park Head to Ask for Salary and Position

Firmly believing that W. Frank Arant, who was deposed in 1913 as superintendent of Crater Lake National Park, was wrongfully removed, J. H. Carnahan and ex-representative Binger Herman are preparing to bring action in the United States court of claims to recover back salary and to get Arant reinstated as park superintendent.

The matter was taken before the Civil Service Commission, and they ruled in favor of Arant's contention. Former Attorney General McReynolds held differently, and upon this ruling, Lane had Arant removed by a federal marshal.

ANOTHER YANKEE VESSEL IS SUNK BY THE GERMANS

VISITING WARSHIP'S REPORT IS CONFIRMED

Sailing Ship, Out of Seattle With Wheat for Queenstown, Is Sent to Bottom in the South Atlantic by Germany Because She Was Alleged to Have a Contraband Cargo—Captain and Crew Are All Safe.

NEWPORT NEWS, March 10.—Officers of the German cruiser Eitel Friedrich today confirmed the reports that the American sailing ship William E. Frye has been sunk. They say the vessel was sunk in the South Atlantic January 27 for carrying contraband.

The Frye sailed from Seattle for Queenstown with a cargo of wheat, leaving November 9. It is reported that the captain and crew of the Frye are aboard the Friedrich.

Woman Accuses Embassy Attache

Mrs. Richard Peter Stegler, wife of the man who was recently arrested by the federal authorities in connection with passport swindles, has told her husband's lawyer, Charles H. Griffith, that she was to get \$150 a month while her husband was a spy in England for the German government, and that Captain Boy-Ed, military attache of the German embassy at Washington, promised she would receive that sum for life if her husband were killed. Mr. Griffith tells this story:

"My client, whose story is corroborated in every detail by his wife, also told me that Captain Boy-Ed, whom he said he met privately in a room in the German Club in Central Park West, New York city, had arranged for the monthly payment of \$150 to Mrs. Stegler, the payments to be continued during Stegler's absence, or in case of his death to be continued during the lifetime of Mrs. Stegler. The Stegliers said that Captain Boy-Ed absolutely refused to sign any papers to bind this agreement. They assert the understanding was that it was to be held as a sacred obligation by the imperial German government.

"When Mrs. Stegler, according to their story, insisted on receiving more definite assurance of where this money was to come from, Stegler was advised, I am informed, that the payment would have to be made through some German company doing business in New York—preferably a steamship company. This was to make everything look regular on the surface."

GERMAN CRUISER CAUSES CONCERN IN HIGH CIRCLES

APPEARS AT NEWPORT NEWS WITH PRISONERS

Question of Interning Vessel With Foreign Prisoners Proved a Hard Puzzle, But the Matter Settled Itself When the Commander said He Would Put to Sea, Being Willing to Take Chances on High Seas.

WASHINGTON, D. C., March 10.—A Newport News message today stated that the German armored cruiser Eitel Friedrich arrived here with 326 prisoners, and might intern, though the object of the visit was not divulged.

Navy Secretary Daniels and President Wilson conferred about the visit of the fighting ship. Later the matter was being considered by the neutrality board of the navy department. Ordinarily the vessel would be allowed a day before being required to intern. The fact that prisoners were carried made the question complicated.

The matter was finally settled, however, when Captain Thierbach, commander of the vessel, announced that he would not intern. It is his intention to have the vessel repaired slightly today and return to sea.

"I have not been captured thus far," he said. "And I'll take more chances."
