Charges Perjury in Becker Case

Harford T. Marshall, a prominent New York lawyer, who was counsel for "Bridgie" Webber, one of the chief witnesses against former Police Lieutenant Charles Becker, sentenced to electrocution in the week ending July 26, at Sing Sing, declares that Webber admitted to him he had committed perjury in the testimony he gave against the policeman. Mr. Marshall has kept silent for two years

but on the eve of the execution of the policeman he has spoken, and he has thus thrown a bomb that has startled all those connected with the case. For, unlike many lawyers practicing in the criminal courts of New York, he is a responsible and able attorney of fine standing.

"Becker had absolutely nothing to do with the murder of Rosenthal," declared Mr. Marshall. "Bridgie" Webber, when he employed me as his counsel at the first trial, admitted this to me, and said that he and the others were perjuring themselves in order to save their own skins. Webber told me that, and I told him to get another lawyer to defend him.

"I think the case is a damned outrage. Becker is an innocent man. I never would have entered the case had I not known from what 'Bridgie' Webber told me that Becker was deliberately 'framed up' by Webber, Harry Vallon, Jack Rose and Sam Schepps."

"Has Webber consented to let you reveal confidential communications between counsel and client? Has he agreed to waive his rights in that respect?" was asked of Mr. Marshall.

"I am going to take a chance on that," replied Mr. Marshall, with a ring of determination in his voice.

"Have you communicated with Webber recently regarding the matter?"

"I have not. I have not seen him since the first trial."

"Do you expect Webber to permit you to disclose what he told you?"

"I do not know, but I expect him to deny the story because of his immunity agreement. I do not intend to make public Webber's conversations with me until I have laid them before Judge Bartlett."

CONSCRIPTION OF U. S. URGED

PROFESSOR OF ENGLISH AT PRINCETON WOULD HAVE SOCIAL AND MILITARY TRAINING FOR NATIONAL EFFICIENCY

EUGENE, July 12.—Conscription for its own sake, not necessarily for war, but for national efficiency in either peace or war, was advocated here in the Fourth of July address delivered at the University of Oregon by J. Duncan Spaeth, who holds the chair of English at Princeton University, formerly held by Ambassador Henry Van Dyke.

Every young American man should be drafted for a year's service, Dr. Spaeth holds, but he said the prevailing idea should not be old-fashioned militarism.

"Constructive social and military training should be given these young men," said the speaker. "For a year they should be put by the government at tasks not of their own choosing, and trained and drilled and disciplined. The young American should learn to take orders and to execute them."

"Our pacifists would do well to understand the real strength of some of the arguments used to bolster up the policy of militarism. It is better to meet these than to ignore them."

"The ability to shoot is not the main thing, even in these days of war. More important are the hardened muscles, bodily endurance and the mind trained to obey. We need these in peace. The one thing needful in our American life is discipline, to keep within bounds and train and break that wild and coltish liberty that spells inefficiency."

"Discipline is not slavery. Discipline sets free. The engine on its track is effective, the ditched engine gets nowhere. We can and must organize to become a better nation and a stronger nation."

Dr. Spaeth's topic was "The New Patriotism." The nineteenth century with all its ways and conditions had gone forever, he declared, and we are all facing an entirely new world, which will never again be like the world of 1913.

"The time is near," declared Dr. Spaeth, "when this nation ought, I believe, to formulate a definite policy with regard to the European war. I do not mean any foolishness about 'going over and stopping this war.' That reminds me of the American woman who saw Vesuvius in eruption, and demanded that something be done to stop it."

"But we should stand against such a 'victory' as each of the European powers is proposing for itself. And we should prepare also to be a mediating upphyphenated nation in a far deeper sense than that. In the long years after the actual warfare has ceased, after the sword has been sheathed and its wounds have healed, there will still rankle and fester the far deeper and more corrupt and poisonous wounds that in the last year have been inflicted by the pen. Truly this war has shown that the pen is deadlier than the sword. We must be the nation then to mediate, and again make the world a possible abiding place for peace. We must step forward without national or racial prejudice, and we must not act from mere economic self interest."

Famous Liberty Bell Now on Way to the Exposition

The Southern Pacific company has handled many shipments of extraordinary value since the last spike was driven in its transcontinental line in 1869, but none quite so valuable as the Liberty Bell, which it will bring into California and to the Panama-Pacific exposition at San Francisco. Consequently the most elaborate precautions are being taken to insure the safe transportation of the priceless relic.

Every precaution will be taken by the Southern Pacific in transferring the bell across the bay from Oakland to San Francisco. A special barge will deliver it to the San Francisco freight slip, where a special freight car and switch engine will be waiting to take it to Third and Townsend streets. Here it will be placed on a truck and carried through the streets of the city to the fair grounds.

The total mileage covered by the Liberty Bell's westward journey is 5,234. The average speed per hour will be twenty-eight miles, the railroads handling the movement having decided that to haul it faster might endanger its safety.

During stops booklets containing the history of the bell, cards with a picture of the relic and buttons also containing a picture of the bell and the American flag will be distributed to the children. It will take hundreds of thousands of these souvenirs to supply the demand. To the governors and mayors, the history of the bell in small bound volume will be presented. Governors have been invited to journey with the bell through their respective states.

The train will arrive in San Francisco Friday night, July 16, and Saturday, July 17, will be Liberty Bell Day at the exposition. Early in the morning the relic will be conveyed to its place in the Pennsylvania building on the exposition grounds, where exercises will be held.

The bell will leave San Francisco in November, and will return by the Southern route, through Los Angeles, San Diego, Arizona and Texas. The details of the return trip have not yet been completed, but it is virtually certain that the special train will go through St. Louis, Indianapolis and Cincinnati.

After each return of the bell to Philadelphia there has been a movement started to prevent the precious metal from leaving the city again. The crack in it has been slowly extending, and there has been fear that in its journey the bell might split in two. Opposition to its leaving the city on this trip was bitter, but the city council voted that it belonged to the American people, and that opportunities to view it should be given whenever possible.

Sending the bell to the Western coast will cost the city of Philadelphia \$75,000. The escorting committee of twenty-six councilmen will pay their own expenses.

The four policemen who will constantly guard the bell were specially picked for their fitness. Each is more than six feet in height. The head of the police department in designating the four men, called them to the front and impressed upon them the following don'ts:

Don't taste any intoxicating liquor while away from Philadelphia.
Don't lose your temper at any time.
Don't fail to uphold the reputation

of Philadelphia policemen for courtesy.
Don't fail to answer every question, however foolish.
Don't fail to at once read the history of the bell, so that you can answer questions accurately.

The first time the bell left Philadelphia was when the British army occupied the city of Philadelphia in 1777-1778. Its subsequent journeys were:

1885—To the World's Industrial and Cotton exposition, New Orleans.

1893—World's Columbian exposition, Chicago.

1895—Cotton States and International exposition, Atlanta.

1902—Charleston exposition.

1903—Battle of Bunker Hill celebration, Boston.

1904—Louisiana Purchase exposition, St. Louis.

The bell entered Oregon at 10:30 yesterday morning, passing through Huntington, Baker, La Grande and Pendleton. From Pendleton it crossed into Washington, and will get back into Oregon at Portland at 6 o'clock on Thursday morning. It will remain at Portland for six hours. At Salem the bell will stop for half an hour, and will arrive in Eugene at 4:50, remaining thirty-five minutes. The next stop will be Cottage Grove, where it will remain for five minutes, and the last stop in Oregon will be at Roseburg for fifteen minutes.
