WILSON'S PREDICAMENT

THE unintended but fortunate disclosure of General Funston's emphatic recommendation that General Pershing's command be withdrawn from Mexico has revealed another important phase of the Mexican situation which the administration has earnestly sought to suppress. Since April 11, General Pershing's command has been kept in Mexico, in constant danger from attack, not permitted to advance, without reinforcements, to the injury of his health and morale, because—President Wilson could not make up his mind, either to continue the pursuit of Villa or to withdraw. In the effort to shift responsibility for any military disaster which might occur, Mr. Wilson and Secretary Baker have persistently avoided asking the military authorities for their opinion, but they inadvertently asked General Funston for his views in connection with the proposed Mexican conference, and the courageous little Kansan, without regard to how unwelcome his words would be to Mr. Wilson, came back with a flat-footed recommendation that the troops be withdrawn from Mexican soil.

The administration tried vainly to suppress the fact that Funston had made this recommendation, but it leaked out and, knowing Funston, they do not dare deny it.

Pershing was ordered into Mexico to "break up the Villa band of bandits," Mr. Wilson said "to get Villa"—following the raid on Columbus March 8th. The punitive expedition was brilliantly led and had nearly captured Villa in the Sierra Madre range when on April 12th, the Carranza forces at Parral treacherously attacked the American troops, killing and wounding several. The Wilson administration immediately became panic stricken, ordered the pursuit abandoned and a "watchful waiting" policy adopted by American troops in hostile country. In great danger and at great expense, the Pershing line into Mexico has been maintained ever since, although if he was not to go forward he had no reason for being there and should have been ordered back. Pershing was then 500 miles below the border.

Finally he was secretly ordered to withdraw to Namiquipa, 260 miles below the border. The retreat of the American soldiers emboldened the Carranzistas again to attack them, at Carrizal, on June 21st, where two officers and a number of troopers were killed. Arrendondo, Carranza's ambassador, informed President Wilson that the Carranza soldiers fired by order of "the first chief." Again the administration became panic stricken and Pershing was secretly ordered to retreat to Colonia Dublan, 130 miles below the border. As every military man knows, although but few say it, Pershing has been kept there for no reason whatsoever save that Mr. Wilson has been unable to make up his mind and because he has feared popular criticism on the one hand if he appeared to yield to Carranza's demand that the American troops be withdrawn, and on the other loss of the belief of some of the uninformed voters that "he has kept us out of war."

Declares New English Armies Good Fighters

LONDON, Aug. 30.—In reports of the great battle of Picardy, being circulated in neutral countries, the commonest misstatement is that the new British armies don't know how to fight. It is admitted that the old expeditionary force was fine material, but the new armies raised in the last two years are described as undisciplined and feeble in attack and irresolute in defense; formidable only because of their numbers, which are vanishing under German fire.

No item of the statement is true. The casualties have not been out of proportion to the ground gained. In the attack of July 14th, which carried a large part of the German second line, the British losses were extraordinarily small. The individual fighting value of the British troops has been equal to any in the campaign. For example, a wood was taken by the Germans with nine battalions; it was recaptured by the British with two. The British new army which showed its merit at Loos last September has won great glory in every phase of a Picardy battle. The whole British force, in one sense, is new. The famous old regiments of the line have been renewed completely since Mons, and their drafts are drawn from the same source as the men of the new battalions. The Ninth and Fifteenth divisions (wholly new) brought from Loos a reputation second to none in the army. Take the great fight of July 14th, when from Pozieres to Delville Wood the German second line was carried, and the third line pierced. A distinguished French soldier doubted the possibility of success. An English general offered to cut his hat if it did not come off. When the French general heard of the result he said "c'est bien. Le General X. ne mange pas son chapeau. Roughly translated: "You win. Don't eat your hat."

In that attack a certain historic British division advanced on the line between Bazentin-le-Grand and Longueval. In each of its three brigades there were two battalions of the new army and two of the old. The attack was made by two brigades, and the general commanding put the four new battalions in the first line. The experiment proved the worth of the new army. To begin with, they managed to

cross the intervening ground and get up to within 200 yards of the enemy's wire practically without casualties—a remarkable proof of discipline. When the intense British bombardment ceased just at dawn they attacked with superb vigor and devotion. In one place the German wire had been imperfectly cut, and they had to make their way through it under a deadly fire. But by a little after midday the wire was done. The German's second position was in their hands, as well as 621 un wounded men, 36 officers, including a battalion commander, four howitzers, four field guns and fourteen machine guns. Such was the achievement of four battalions of the new army which had never been in action.

The Germans were not weak in that section. The misty weather had enabled them to mass guns whose positions could not be detected. They had brought up some of their most famous troops. The truth is that it is idle to talk of old and new armies. The British army, old army, new army and territorial, home divisions and colonial divisions, have alike proved themselves adequate for the task of war.

Today on the plateau between the Sambre and the Somme, it is no patchwork force that is engaged, but the flower of the manhood of the British Empire.

FOOTBALL WORK TO BEGIN SOON

SEASON THIS YEAR WILL BEGIN EARLIER AND CONTINUE LATER THAN IN FORMER YEARS, SAYS SPORT CRITIC

NEW YORK, Aug. 30.—Apparently someone went wrong when arrangements were being made for the big Eastern football games this fall. A glance at the schedules of Yale and Harvard universities and the Army and Navy teams is enough to prove this. Ordinarily Yale and Harvard meet in their annual gridiron battle the Saturday preceding Thanksgiving, and Army and Navy do their historic stunt the following Saturday.

This year, however, the schedule makers have seen things differently, and the two big games will be staged the same day—Yale and Harvard in the bowl at New Haven, and the Army and Navy at New York.

The football season this year is going to start just a little ahead of the conventional time. The University of California will usher in the season officially on September 16th. Seven days later Harvard, Dartmouth and Georgetown will be seen in action. Also, the season will be a bit longer this year than is the custom, the last game not being scheduled until December 9th.

Important Thanksgiving day games include Cornell and Pennsylvania in the East; Vanderbilt vs. University of the South, and Kentucky vs. Tennessee in the South; Nebraska vs. Notre Dame, California vs. Washington, and Southern California vs. Oregon Aggies in the West.
