LIEBKNECHT IS SENT TO PRISON

NOTED GERMAN SOCIALIST, WHO LED ANTI-WAR DEMONSTRATION, IS EXPELLED FROM BAR AND IMPRISONED

ZURICH, Jan. 18.—Karl Liebknecht, the German socialist, has been sentenced to four and a half years imprisonment at hard labor, and has been expelled from the bar, according to reports from Berlin.

This is probably the result of his participation in the anti-war demonstration last year.

LAKEVIEW GIVES TRACTS FOR ROAD

LAKE COUNTY FARMERS COME TO FRONT WITH RIGHT OF WAY FOR STRAHORN RAILROAD FROM LAKEVIEW

LAKEVIEW, Jan. 18.—The deeds for the first fifteen miles of the right of way of the Strahorn railroad out of Lakeview have been filed with County Clerk Payne. This entire amount has been donated by the farmers living along the right of way. Not a foot of ground has been purchased. However, there are a few of the farmers who are somewhat loath to give the land. Their main complaint is that the road goes through their best land, but in case the survey is changed slightly they will give the land.

No trouble is expected in getting the necessary right of way. The terminals in Lakeview and the right of way through the town have not been taken as yet, and no action will be taken until the actual construction of the road has begun.

Lakeview has voted \$20,000 for purchasing terminals and rights of way.

Author of 8-Hour Bill



Representative Williamson of Georgia, whose railroad bills of the last session of congress averted the threatened strike, has brought forth a new bill, one which is regarded as one of the most important offered in congress. He proposes an eight hour day for railroad employees by compulsion, except in those cases where exemptions may be made by the Interstate Commerce Commission.

LAWYERS DON'T WANT OFFICE OF CLERK ABOLISHED

PROTEST AGAINST BALDWIN SENATE BILL

Klamath Senator Would Kill Office Now Held by George Chastain on Grounds of Economy—Bar Association Protests for Itself, and Asks Others to Protest—Fees of Office Almost Doubled

The ire of the Klamath County Bar Association has been aroused by the action of George T. Baldwin, state senator from this district, in introducing in the legislature a bill to abolish the office of clerk of the circuit court, now held by George Chastain.

At a meeting this afternoon the bar authorized President W. S. Wiley to name a committee of three to draft resolutions of protest against the bill, and to forward the resolutions to Salem. J. C. Reynolds, Horace M. Manning and W. H. A. Renner were named on the committee.

President Wiley was then authorized to name another committee to call on the county court and other bodies or individuals to urge them to help defeat the bill. W. M. Duncan, J. H. Carahan and R. C. Greenback were named on this committee.

The following dispatch from Salem tells of Judge Baldwin's measure:

SALEM, Jan. 18.—Senator Baldwin has introduced his economy program at home by introducing a bill for the abolition of the office of clerk of the circuit court in Klamath county.

"This is the only county in the state having such an office," said the senator. "It was created in the 1915 session, is unnecessary and the people can be saved about \$1,700 annually if it is abolished. Since the office is elective, my bill will not become operative, if passed, until the expiration of the term of the present occupant of the office."

The office of clerk of the circuit court was created in June, 1913, and since then has about paid for itself in fees. The salary of the clerk is \$1,500. Following are the fees collected since the office was created:

June, 1913, to June, 1914	\$3,305

Chief of Bandits Rout Carranzistas at Palomas



EL PASO, Tex., Jan. 18.—Pancho Villa yesterday repulsed several thousand Carranzistas in a fierce battle at Palomas, inflicting heavy losses to the federal troops, according to reports reaching the border.

General Murgua last night drew every available soldier from the Chihuahua City garrison to enforce the defeated troops.

The battle now is in its sixth day.

Goldsmith conducted a ladies' tailor shop and Bowdoin & Tugnot a job printing shop in the building. Practically all the goods in both establishments were removed, and what damage was done will be mostly from water.

Neither of the establishments carried any insurance on their property. The building belonged to E. H. DuPaul.

The fire burned for some time before water could be obtained because the hydrant at Third and Main streets was frozen up. The fire could not be fought until the hydrant had been thawed out with hot water.

MUST NOT SCARE FISH SAY BILL

THE SCREENS ON IRRIGATION DITCHES MUST BE CONSTRUCTED UNDER REGULATIONS IF BILL PASSES LEGISLATURE

SALEM, Jan. 18.—Screens and other devices for keeping fish out of irrigation ditches must be so constructed as not to frighten the fish, according to house bill No. 102, introduced by Sweeney of Josephine. It is left to the judgment of the fish and game commission to determine what will frighten the fish.

Another fish bill, house bill No. 103, was introduced by Brownell of Clackamas, making it lawful to fish for salmon with hook and line at all seasons of the year. Set lines are prohibited by the act, and the maximum daily catch is fixed at three salmon.

Bob sees the girl running about in the woods, mistaking her for a wild animal, fires, wounding her in the arm. This leads to their meeting. By a series of cutbacks, it is shown that the girl had been a denizen of the forest after her mother and sister had been killed by Indians. It develops that the gambler is the girl's father, but instead of the usual recognition scene between father and daughter, the story sends the gambler away without knowing who the girl is. Neither does she know that the gambler is her father.
