Military Training Bill Reported on Favorably

WASHINGTON, D. C., Feb. 12.—The military affairs committee has reported favorably on Senator Chamberlain's bill for universal military training. The bill provides that every male citizen from 18 to 26 years of age must undergo six months military or special training, beginning January 1, 1918.

Following six months training he shall become a member of a citizen's reserve force until 28 years old. During this period he is liable to call by the president for inspection and for

each year. The training is to be done in the 1918 year of all citizens. It is estimated the bill would provide for the training of 1,000,000 annually, each of whom would be brought into a reserve for nine months after the training period. With allowances for carriage of classes, the training would cost the government \$1,000,000,000 over the next five years. The bill would give a total term of 1,000,000 over the next five years. GERARD WIRES PRES. WILSON HEADS COMMITTEE

AMBASSADOR REACHES BERNE, AND IMMEDIATELY COMMUNICATES WITH WILSON OVER GERMAN ATTITUDE

By CARL ACKERMAN BERNE, Switzerland, Feb. 11.—Germany is delaying the departure of many Americans within her boundary for possible retaliatory measures in the event of war. Germany is striving to avert a war with the United States, but German militarists prepared for American hostilities long ago.

Arriving here last night Ambassador Gerard began communicating with President Wilson. He told of Germany's threat to hold American correspondents as hostages unless Gerard signed a treaty guaranteeing that German ships in American harbors will be permitted to leave in the event of war. It is understood that Gerard delivered an ultimatum to this effect Monday.

Gerard refused to negotiate, declaring that his diplomatic authority was ended. He plainly told Count Montenegro that if Americans are forced to remain in Germany, America would regard it as a casus belli.
