ShoeJournalists Plan To
Handle War Literature

SEATTLE, Jan. 17.—Attempts to formulate a definite policy for handling masses of war literature and newspaper stories contributed by various bureaus and war organizations, which are now flooding into newspaper offices, will be made at the sixth annual Washington Newspaper Institute, which opens here today at the University of Washington.

As the various bureaus commissions and administrators appointed

so hastily after the entrance of the United States into the war could not work effectively without the co-operation of the people, they attempted to reach the people quickly thru the newspapers," asserted Colin Dymont, head of the University Department of Journalism recently. "The outcome was natural, for no country newspaper and only a few of the large city dailies could meet the demands made upon them for space. We will endeavor to solve the problem at the institute."

Herman Steinheimer, a full-blooded German of Cherokee, Oklahoma, is discouraged over the lack of support given the food administration in the observance of "meatless days." He conducts a butcher shop in that city, and as his other efforts to discourage the purchase of meat on "meatless" days have not met with the desired

success, he has issued the following statement to the public:

"Tuesday is meatless day, and there will not be a pound of meat for sale at my place. Of course I will have plenty of it, but they can't get it with a gun. It will be locked up, and they can save themselves the embarrassment of being turned down."

HIGH SCHOOL NOTES

Wednesday and Thursday of this week are being devoted to the regular semester examinations. Friday will be devoted to the closing up of the records of the semester and also to examinations in outside Bible study. The examination on the New Testament will occur at 9 o'clock in the morning, and on the Old Testament at 1:30. The next examination in Bible study will occur the 17th of May. The preparation on this work is done entirely at home or at Sunday school, and the examination is given by the state department of education, and the papers are graded there, the pupil receives the credit in high school.

INDIAN IS
GUILTY OF
FORGERY

CHANGES HIS PLEA IN CIRCUIT COURT TO "GUILTY"—FORGED NAME OF STUCKMAN TO CHECK FOR EIGHTY-FIVE DOLLARS

The case which was scheduled last on the docket in the Circuit Court, that of the State vs. Roy Walker, charged with forgery, has been dismissed, as the defendant yesterday changed his plea of "not guilty" to one of "guilty."

Walker, who is a young Indian on the Klamath reservation, forged a check on the First National bank with the name of J. Frank Adams for the sum of \$85.

His sentence has been continued until February 1st. It is reported that the health of the defendant is poor, and that the passing of the sentence has been delayed on this account.
