There has been no time when it was colder than freezing, and the most snow seen on the ground at any one time was about eight inches. Our health as a whole has been perfect. Not a sick or bad feeling day. The medical "kit" purchased for emergencies has not been used. Our appetites for three meals a day have kept up to record, and at times been heartier than usual.

Spring Creek is a never-ending spot of beauty. The water and snow scenes are not surpassed in the world. The evergreen trees and other mountain foliage are always pleasant scenes.

There has not been a day during the winter but what we could use our automobile. In order to insure a means of transportation in case storms made it impossible to go in a car, we have kept a mule horse. The postoffice being but five miles.

I most earnestly hope that I may be able to spend the rest of my life upon the banks of this beautiful stream.

The winter fishing here is very fine and the hunting is unsurpassed, and the territory for this sport is limited.

Folks, when you have the time, and want to go to a real place, one that will mean much to you, come to Spring Creek and spend a month. You will become a new person entirely, and it will not cost as much as your regular living expenses in town.
